To The Head of Vernal City Police:

I ask for a deeper investigation on this case. I also have a message for Detective Dallon Colum, I don't know what is your basis you put in my name that I am armed, dangerous and violent. I am not armed. I am not dangerous and I am not violent. Never did I hurt anyone in the Philippines. And I have no criminal record with the police. The information provided to the Interpol were incorrect. It claims I have killed 6 persons in the Philippines which is false. I respect the detectives and investigators but these false information needs to be clarified because it has major consequences and putting my life in danger. There was a write up at additional information on the Red Notice from Interpol that this person Mr. Resuera has killed 6 persons possibly in the Philippines. I want you to know that people in the Philippines are not chicken. It's not easy to kill here. Even if you killed someone here by accident you will face a big trouble. I challenge you detective Dallon Colum come to the Philippines and my place. You can coordinate with the Phillipine National Police or NBI. And if you can find out that I killed someone here or I have any criminal record. I will voluntary go back to your country. All of a sudden you changed my life by putting false accusations and information. That is why I lose my hope, I lose my trust the way you investigate that is why I am calling the attention of FBI Salt Lake to director Kash Patel, Sir if you can send someone from your team to dig deeper reinvestigation. I am willing to cooperate and submit everything that I have. Thank you so much.

Message to the Family of Kim:

My words are not enough to console all of you. I apologize for keeping silent up to this time. It took me so long to have the courage to tell everything I know, as I was afraid for the safety of my family. They suffered a lot during the interrogation and investigation, and I don't want them to suffer even more. Losing Kim was not just losing a neighbor but losing a friend, a mother, a grandmother and a family. She's one of the wonderful people I know. I will be the key to solve this mystery. Who would benefit if something happened to Kim? All I can say it was really Mike who was the mastermind all of this. He set me up for his selfish interest. I hope justice be served and put the killers behind bars. All my statement here and allegations are supported with documents.

Message to Mike:

I thought we were friends. Why you allowed me to be involved in this. I am talking to you, man-to-man, father-to-father. Tell the truth. It's not too late Mike. One day you will face Kimberly afterlife . I know you have totally moved on but please you are my only hope to clear my name because I know you knew who did this. Now there are 3 children suffering because they are living without a father by their side.

To the People I met in the Gym:

I don't know your names but every time we see each other, we greet. I hope you are watching this video and for the sake of my kids and my family especially to help me clear my name. Please show up and testify that I was at the gym on October 7, 2024 between 2:30 to 3:30 pm.

I am calling the attention of your amazing president, Donald Trump. Mr. President, from the bottom of my heart and with a clear conscience, I did not kill your citizen. We came to the US to live our American dream and to give a better future for our kids and not to harm anyone. Please help the family of the victim. Give them peace of mind and peace of heart.
