After consideration on the merits, the Committee recommends the following:

HB25-1212 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 3, strike lines 2 through 10.
- 2 Renumber succeeding subsections accordingly.
- 3 Page 3, line 13, after "DATA;" add "AND".
- 4 Page 3, strike line 14.
- 5 Reletter succeeding paragraph accordingly.
- 6 Page 3, before line 16 insert:
 - 7 "(3) "LARGE ARTIFICIAL INTELLIGENCE DEVELOPER" MEANS AN
 - 8 ENTITY THAT:
 - 9 (a) IS AN EMPLOYER AS DEFINED IN SECTION 8-4-101 (6) OR AN
 - 10 ENTITY THAT CONTRACTS WITH FIVE OR MORE INDEPENDENT
 - 11 CONTRACTORS IN THE STATE EACH YEAR;
 - 12 (b) HAS, WITHIN THE PRECEDING FIVE YEARS, TRAINED A
 - 13 FOUNDATION MODEL AT A COMPUTATIONAL COST OF AT LEAST TWENTY
 - 14 MILLION DOLLARS AS MEASURED BY THE AVERAGE COST OF AN
 - 15 EQUIVALENT AMOUNT OF CLOUD COMPUTING AT THE TIME THAT TRAINING
 - 16 COMMENCES; AND
 - 17 (c) HAS, WITHIN ANY TWELVE-MONTH PERIOD DURING THE
 - 18 PRECEDING FIVE YEARS, TRAINED ONE OR MORE FOUNDATION MODELS AT
 - 19 A TOTAL COMPUTATIONAL COST OF AT LEAST ONE HUNDRED MILLION
 - 20 DOLLARS AS MEASURED BY THE AVERAGE COST OF AN EQUIVALENT
 - 21 AMOUNT OF CLOUD COMPUTING AT THE TIME THAT TRAINING COMMENCES.
 - 22 (4) "RISK TO PUBLIC SAFETY OR SECURITY" MEANS A RISK THAT A
 - 23 FOUNDATION MODEL COULD CAUSE OR MATERIALLY ENABLE DEATH,

- 1 BODILY INJURY, OR DAMAGE TO PROPERTY.".
- 2 Renumber succeeding subsection accordingly.
- 3 Page 7, line 3, strike "HOWEVER, IF THE DEVELOPER".
- 4 Page 7, strike lines 4 through 7.
- 5 Page 7, after line 20 insert:
- 6 "8-13.6-107. Trade secrets. THIS ARTICLE 13.6 DOES NOT PERMIT
7 A WORKER TO DISCLOSE A TRADE SECRET, AS DEFINED IN 18 U.S.C. SEC.
8 1839 (3), WHEN SUCH DISCLOSURE IS PROHIBITED BY 18 U.S.C. SECS. 1831
9 TO 1839.".
