

1 **SECTION 11. Appropriation to the department of local**
2 **affairs for the fiscal year beginning July 1, 2020.** In Session Laws
3 of Colorado 2021, **amend** section 15 (3) of chapter 371, (HB
4 21-1289), as follows:

5 Section 15. **Appropriations.** (3) For the 2020-21 state fiscal
6 year, \$5,000,000 is appropriated to the department of local affairs for
7 use by the division of local government. This appropriation is from the
8 interconnectivity grant program fund created in section 24-32-104
9 (7)(c), C.R.S., and of money the state received from the federal
10 coronavirus state fiscal recovery fund. The division of local
11 government may use this appropriation to implement the
12 interconnectivity grant program created in section 24-32-104 (7)(a),
13 C.R.S. Any money appropriated in this subsection (3) not expended
14 prior to ~~July 1, 2021~~ JULY 1, 2022, is further appropriated to the
15 department of local affairs for use by the division of local government
16 for the ~~2021-22~~ 2022-23 state fiscal year for the same purpose.

17 **SECTION 12. Appropriation to the departments of natural**
18 **resources and personnel for the fiscal year beginning July 1,**
19 **2020.** In Session Laws of Colorado 2021, **amend** section 6 (3), of
20 chapter 274, (HB 21-1326), as follows:

21 Section 6. **Appropriation.** (3) For the 2020-21 state fiscal

1 year ~~and on an ongoing basis~~, \$43,200 is appropriated to the
2 department of personnel. This appropriation is from reappropriated
3 funds received from the department of natural resources ~~pursuant to~~
4 UNDER subsection (2)(a)(II) of this section. To implement this act, the
5 department of personnel may use this appropriation ~~for vehicle~~
6 ~~replacement leases or purchases in fleet management program and~~
7 ~~motor pool services~~. TO PROVIDE VEHICLES TO THE DEPARTMENT OF
8 NATURAL RESOURCES.

9 **SECTION 13. Appropriation to the department of**
10 **education for the fiscal year beginning July 1, 2021.** In Session
11 Laws of Colorado 2021, **amend** section 42 of chapter 222, (SB
12 21-268), as follows:

13 Section 42. **Appropriation.** For the 2021-22 state fiscal year,
14 \$410,221 is appropriated to the department of education. This
15 appropriation is from the general fund. To implement this act, the
16 department may use this appropriation for the Colorado imagination
17 library program. ANY MONEY APPROPRIATED IN THIS SECTION NOT
18 EXPENDED PRIOR TO JULY 1, 2022, IS FURTHER APPROPRIATED TO THE
19 DEPARTMENT FOR THE 2022-23 STATE FISCAL YEAR FOR THE SAME
20 PURPOSE.

21 **SECTION 14. Appropriation to the departments of natural**

1 **resources and personnel for the fiscal year beginning July 1,**
2 **2021.** In Session Laws of Colorado 2021, **add** section 8 to chapter
3 274, (HB 21-1326), as follows:

4 Section 8. **Appropriation.** (1) FOR THE 2021-22 STATE FISCAL
5 YEAR, \$43,200 IS APPROPRIATED TO THE DEPARTMENT OF NATURAL
6 RESOURCES FOR USE BY THE DIVISION OF PARKS AND WILDLIFE. THIS
7 APPROPRIATION IS FROM THE PARKS AND OUTDOOR RECREATION CASH
8 FUND CREATED IN SECTION 33-10-111 (1), C.R.S. TO IMPLEMENT THIS
9 ACT, THE DIVISION MAY USE THIS APPROPRIATION FOR VEHICLE LEASE
10 PAYMENTS.

11 (2) FOR THE 2021-22 STATE FISCAL YEAR, \$43,200 IS
12 APPROPRIATED TO THE DEPARTMENT OF PERSONNEL. THIS
13 APPROPRIATION IS FROM REAPPROPRIATED FUNDS RECEIVED FROM THE
14 DEPARTMENT OF NATURAL RESOURCES UNDER SUBSECTION (1) OF THIS
15 SECTION. TO IMPLEMENT THIS ACT, THE DEPARTMENT OF PERSONNEL
16 MAY USE THIS APPROPRIATION TO PROVIDE VEHICLES TO THE
17 DEPARTMENT OF NATURAL RESOURCES.

18 **SECTION 15. Appropriation to the department of public**
19 **health and environment for the fiscal year beginning July 1,**
20 **2021.** In Session Laws of Colorado 2021, **amend** section 12,
21 introductory portion to (2), (2)(a), and (2)(b) of chapter 313, (HB

1 21-1317), as follows:

2 Section 12. **Appropriation.** (2) For the 2021-22 state fiscal
3 year, ~~\$541,826~~ \$301,042 is appropriated to the department of public
4 health and environment for use by the center for health and
5 environmental information. This appropriation consists of \$265,656
6 from the general fund and ~~\$276,170~~ \$35,386 from the medical
7 marijuana program cash fund created in section 25-1.5-106 (16)(a),
8 C.R.S. To implement this act, the center may use this appropriation as
9 follows:

10 (a) ~~\$110,935~~ \$34,306 from the medical marijuana program cash
11 fund for personal services related to the medical marijuana registry,
12 which amount is based on an assumption that the registry will require
13 an additional ~~2.1 FTE~~ 0.8 FTE;

14 (b) ~~\$165,235~~ \$1,080 from the medical marijuana program cash
15 fund for operating expenses related to the medical marijuana registry;

16 **SECTION 16. Appropriation to the department of**
17 **regulatory agencies for the fiscal year beginning July 1, 2021.** In
18 Session Laws of Colorado 2021, **amend** section 11 of chapter 220, (SB
19 21-272), as follows:

20 Section 11. **Appropriation - adjustments to House Bill**
21 **21-1269.** (1) To implement this act, appropriations made in H.B.

1 21-1269 for the 2021-22 state fiscal year to the department of
2 regulatory agencies for use by the public utilities commission are
3 adjusted as follows:

4 (a) The general fund appropriation for personal services is
5 decreased by ~~\$41,391~~ \$41,381, and the related FTE is decreased by 0.5
6 FTE; and

7 (b) The general fund appropriation for operating expenses is
8 decreased by \$7,010.

9 **SECTION 17. Appropriation to the department of**
10 **transportation for the fiscal year beginning July 1, 2021.** In
11 Session Laws of Colorado 2021, **add** (1.5) to section 55 of chapter
12 250, (SB 21-260), as follows:

13 Section 55. **Appropriation.** (1.5) ANY MONEY APPROPRIATED
14 IN SUBSECTION (1)(c) OF THIS SECTION NOT EXPENDED PRIOR TO JULY 1,
15 2022, IS FURTHER APPROPRIATED TO THE DEPARTMENT THROUGH THE
16 CLOSE OF THE 2024-25 STATE FISCAL YEAR FOR THE SAME PURPOSE.

17 **SECTION 18. Safety clause.** The general assembly hereby
18 finds, determines, and declares that this act is necessary for the
19 immediate preservation of the public peace, health, and safety.
