## **Summary of Legislation**

The bill creates the 17-member Educator Safety Task Force to study issues relating to safety of public school staff. By July 1, 2024, appointments to the task force must be made by the Governor, Speaker of the House, President of the Senate, and House and Senate Minority Leaders. The task force must meet at least seven times in FY 2024-25, with the first meeting by September 1, 2024. The task force must study:

- laws and regulations that affect safety of public school staff;
- the influence of special education professionals on student behavior;
- the effect of staff shortages, increased class sizes and caseloads on disruptive learning environments;
- aggressive student behaviors towards public school staff;
- recommendations of other school task forces; and,
- the effect of insufficient school funding and resource inequality on learning environments and public school staff safety.

The task force must make recommendations and submit a report to the legislature by June 30, 2025. The bill is repealed on December 31, 2025.

## **State Expenditures**

**Department of Public Safety.** The bill will increase state expenditures in the Department of Public Safety (DPS) in FY 2024-25 only, paid from the General Fund. It is assumed that the DPS will convene the task force for 13 meetings, requiring approximately 50 hours of contracted service hours per meeting. These contractors will collect data, write reports, and facilitate meetings at a rate of \$225 per hour, resulting in total costs of \$146,250. Estimates are based on similar task force for the DPS. If the task force meets less or more frequently than assumed, costs may vary from this estimate.

**Governor's Office and Legislative Branch.** Workload will increase for the Governor and legislative leadership to make the required appointments to the task force. This additional workload is assumed to be minimal; no additional appropriation is required.

## **Other Budget Impacts**

**General Fund reserve.** Under current law, an amount equal to 15 percent of General Fund appropriations must be set aside in the General Fund statutory reserve. Based on this fiscal note, the bill is expected to increase the amount of General Fund held in reserve by the amounts shown in Table 1, decreasing the amount of General Fund available for other purposes.

## **School District**

Public school staff members who are appointed to the task force will attend the task force meetings and assist in developing the required recommendations. Time spent attending these meeting may require substitute staff coverage depending on when the task force chooses to meet. Additional expenses to cover staff absences are assumed to be minimal.

## **Effective Date**

The bill takes effect upon signature of the Governor, or upon becoming law without his signature.

## **State Appropriations**

For FY 2024-25, the bill requires a General Fund appropriation of \$146,250 to the Department of Public Safety
