Bill Summary

The bill establishes the center for research into prevention strategies for, and treatment of, abuse of and addiction to opioids, other

controlled substances, and alcohol at the university of Colorado health sciences center.

The bill makes an appropriation.

9	HEALTH CONCERN IN COLORADO, WITH MORE THAN TEN THOUSAND
10	DEATHS ATTRIBUTED TO DRUG OVERDOSES SINCE 2000, AND THE ANNUAL
11	RATE OF DEATH FROM DRUG OVERDOSE DOUBLING FROM
12	SEVEN-POINT-EIGHT DEATHS PER ONE HUNDRED THOUSAND PEOPLE IN
13	2000 to fifteen-point-seven deaths per one hundred thousand

22	(d) ACCORDING TO THE CENTERS FOR DISEASE CONTROL,
23	COLORADO'S DRUG OVERDOSE MORTALITY RATE HAS INCREASED BY FIVE
24	HUNDRED PERCENT SINCE 2014;
