Current Appropriations Clause in Bill

The bill requires but does not contain an appropriation clause.

Description of Amendments in This Packet

- **J.001** Staff has prepared amendment **J.001** (attached) to add a provision appropriating \$100,000 General Fund to the Department of Higher Education for FY 2023-24. Statutory provisions included in the bill, as amended, specify that any amount appropriated but not expended by July 1, 2024 is further appropriated for the same purpose through FY 2025-26.
- **L.005** Bill Sponsor amendment **L.005** (attached) makes various technical changes to the bill, including: (1) requiring specific types of organizations be selected as youth mentorship organizations; (2) clarifying that appropriated funds may not be used for Department or Colorado Opportunity Scholarship Initiative board administrative costs; and (3) removing a provision requiring equal funding for each approved grantee organization.

Legislative Council Staff and JBC Staff concur that amendment L.005 does not change the bill's fiscal impact. The Committee may adopt J.001 and L.005.

Points to Consider

General Fund Impact

The Joint Budget Committee (JBC) is developing a budget package for FY 2023-24. This bill requires a General Fund appropriation of \$100,000 for FY 2023-24, reducing the General Fund available for other FY 2023-24 appropriations by this amount.
