Sunset Process - House Judiciary Committee. The bill implements the recommendations of the sunset review and report on the deterrence of identity theft and financial fraud by:

- ! Extending the automatic termination date of the Colorado fraud investigators unit to September 1, 2025, pursuant to the sunset law (**sections 1 and 2** of the bill); and

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-33.5-1708,
3 **amend** (1) as follows:

4 **24-33.5-1708. Repeal of part.** (1) This part 17 is repealed,
5 effective September 1, 2016 2025.

6 **SECTION 2.** In Colorado Revised Statutes, 24-34-104, **repeal**
7 (47.5) (c); and **add** (56) (d) as follows:

8 **24-34-104. General assembly review of regulatory agencies**
9 **and functions for termination, continuation, or reestablishment.**
10 (47.5) The following agencies, functions, or both, shall terminate on
11 September 1, 2016:

12 (c) The identity theft and financial fraud board and the Colorado

19 **SECTION 3. Act subject to petition - effective date -**
20 **applicability.** (1) This act takes effect at 12:01 a.m. on the day following
21 the expiration of the ninety-day period after final adjournment of the
22 general assembly (August 10, 2016, if adjournment sine die is on May 11,
23 2016); except that, if a referendum petition is filed pursuant to section 1
24 (3) of article V of the state constitution against this act or an item, section,

1 or part of this act within such period, then the act, item, section, or part
2 will not take effect unless approved by the people at the general election
3 to be held in November 2016 and, in such case, will take effect on the
4 date of the official declaration of the vote thereon by the governor.

5 (2) This act applies to conduct occurring on or after the applicable
6 effective date of this act.
