Summary Information

Overview. The bill delays the inclusion of certain residential treatment services for foster youth in the state’s Medicaid managed care system until July 1, 2026

Types of impacts. The bill is projected to affect the following areas on an ongoing basis:

Summary of Legislation

The bill delays the transition of residential treatment services for foster youth in county custody into the state's managed care system until July 1, 2026. By December 1, 2025, the Department of Health Care Policy and Financing (HCPF) must work with the Department of Human Services (CDHS), the Behavioral Health Administration (BHA), and other stakeholders to develop policies for the transition of these services to the managed care system.

Background

Currently, most Medicaid behavioral health services for children in county custody are delivered through capitated payments to Regional Accountable Entities, which are managed care entities that are paid a per-member per-month rate to provide behavioral health services. However, residential treatment services for foster youth, including services in qualified residential treatment programs or psychiatric residential treatment facilities, are excluded from the behavioral health capitation system, with services paid through a child welfare "carve out" in HCPF's budget on a fee-for-service basis.

HCPF planned to shift residential treatment services to behavioral health capitation for child welfare youth by July 1, 2025. The shift is partly in response to a statutory change made through [House Bill 18-1328](#) that removed the legal basis for the carve-out and the ability for these services to remain outside of managed care.

State Expenditures

The bill minimally increases workload for HCPF, CDHS, and the BHA in FY 2025-26 to collaborate with stakeholders and develop transition policies by December 1, 2025. Implementation of the policy will begin in FY 2026-27. This workload can be accomplished within existing resources.

Effective Date

The bill takes effect upon signature of the Governor, or upon becoming law without his signature.
