2           **SECTION 1.** In Colorado Revised Statutes, 25-1.5-504, **repeal**  
3       (6) as follows:

4           **25-1.5-504. Colorado health service corps advisory council -**  
5       **creation - membership - duties.** (6) (a) ~~This section is repealed;~~

9           **SECTION 2.** In Colorado Revised Statutes, 2-3-1203, **repeal**  
10      (4)(a)(VI) as follows:

11           **2-3-1203. Sunset review of advisory committees - legislative**  
12       **declaration - definition - repeal.** (4) (a) The following statutory  
13       authorizations for the designated advisory committees will repeal on July  
14       1, 2017:

15           ~~(VI) The Colorado health service corps advisory council created~~

17           **SECTION 3. Safety clause.** The general assembly hereby finds,  
18       determines, and declares that this act is necessary for the immediate  
19       preservation of the public peace, health, and safety.
