102	CONTROLLED MAINTENANCE TRUST FUND OF MONEY THAT WILL
103	BE AVAILABLE TO THE GOVERNOR FOR A LIMITED TIME FOR
104	FURTHER TRANSFER TO THE DISASTER EMERGENCY FUND FOR
105	PUBLIC HEALTH AND EMERGENCY RESPONSE EXPENSES
106	ASSOCIATED WITH THE COVID-19 PANDEMIC EMERGENCY.

state emergency reserve under TABOR, and the governor has twice ordered money from the trust fund to be transferred to the disaster emergency fund to be used for response activities related to COVID-19. The bill requires the state treasurer to transfer \$100 million from the general fund to the controlled maintenance trust fund. For this fiscal year, this money will be available to the governor to transfer to the disaster emergency fund for public health and emergency response expenses associated with the COVID-19 pandemic emergency.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1. Legislative declaration.** (1) The general assembly 3 hereby finds and declares that: 4 (a) In the annual general appropriations act for the 2020-21 fiscal 5 year, the general assembly designated seventy-three million dollars in the 6 controlled maintenance trust fund, created in section 24-75-302.5 (2)(a), 7 Colorado Revised Statutes, and seventy-five million dollars in the disaster 8 emergency fund, created in section 24-33.5-706 (2)(a), Colorado Revised 9 Statutes, as part of the state emergency reserve required by article X, 10 section 20 (5) of the Colorado constitution; 11 (b) On April 8, 2020, as part of Executive Order D 2020 032, 12 Governor Polis ordered twenty-three million dollars to be transferred 13 from the controlled maintenance trust fund to the disaster emergency 14 fund, created in section 24-33.5-706 (2), Colorado Revised Statutes, and 15 encumbered the money for response activities related to COVID-19; 16 (c) On November 19, 2020, as part of Executive Order D 2020 17 258, Governor Polis ordered an additional sixty million five hundred 18 thousand dollars to be transferred from the controlled maintenance trust 19 fund to the disaster emergency fund, and likewise encumbered the money 20 for response activities related to COVID-19; 21 (d) Governor Polis has encumbered two hundred eighty-six

I	million thirty-eight thousand six hundred forty-eight dollars from the
2	disaster emergency fund for response activities related to COVID-19
3	through a series of executive orders, most recently in Executive Order D
4	2020 258, and this encumbered amount includes money designated as part
5	of the state emergency reserve;
6	(e) While not required by article X, section 20 (5) of the Colorado
7	constitution, it is prudent to replenish the cash reserves that are available
8	to address additional, unanticipated response activities related to
9	COVID-19 by transferring money to the controlled maintenance trust
10	fund;
11	(f) If the transferred money is not needed in the 2020-21 fiscal
12	year to respond to COVID-19, then it will remain in the trust fund and be
13	available for the general assembly to designate as part of the state
14	emergency reserve for the next fiscal year.
15	(2) Now, therefore, it is the intent of the general assembly to
16	transfer money from the general fund to the controlled maintenance trust
17	fund to ensure that the state has sufficient money available to pay for any
18	unanticipated COVID-19 response activities.
19	SECTION 2. In Colorado Revised Statutes, 24-75-302.5, add
20	(2.7) as follows:
21	24-75-302.5. Controlled maintenance - trust fund - legislative
22	<b>declaration.</b> (2.7) (a) On the effective date of this subsection
23	(2.7)(a), the state treasurer shall transfer one hundred million
24	DOLLARS FROM THE GENERAL FUND TO THE CONTROLLED MAINTENANCE
25	TRUST FUND.
26	(b) (I) Prior to July 1, 2021, the governor may transfer to
27	THE DISASTER EMERGENCY FUND, CREATED IN SECTION 24-33.5-706 (2)(a),

1	ANY MONEY IN THE CONTROLLED MAINTENANCE TRUST FUND
2	TRANSFERRED THERETO IN ACCORDANCE WITH SUBSECTION (2.7)(a) OF
3	THIS SECTION, IF THE MONEY AVAILABLE IN THE DISASTER EMERGENCY
4	FUND IS INSUFFICIENT FOR THE PUBLIC HEALTH AND EMERGENCY
5	RESPONSE COSTS ASSOCIATED WITH THE COVID-19 PANDEMIC
6	EMERGENCY. NO OTHER TRANSFERS OF THIS MONEY TO THE DISASTER
7	EMERGENCY FUND ARE PERMITTED.
8	(II) IF, AFTER THE DATE OF A TRANSFER TO THE DISASTER
9	EMERGENCY FUND UNDER SUBSECTION (2.7)(b)(I) OF THIS SECTION, THE
10	STATE RECEIVES A REIMBURSEMENT FROM THE FEDERAL GOVERNMENT
11	FOR ANY EXPENDITURES FROM THE DISASTER EMERGENCY FUND, THE
12	STATE TREASURER SHALL DEPOSIT THE REIMBURSEMENT INTO THE
13	CONTROLLED MAINTENANCE TRUST FUND; EXCEPT THAT THE DEPOSITED
14	AMOUNT SHALL NOT EXCEED THE AMOUNT TRANSFERRED UNDER
15	SUBSECTION (2.7)(b)(I) OF THIS SECTION.
16	SECTION 3. Safety clause. The general assembly hereby finds,
17	determines, and declares that this act is necessary for the immediate
18	preservation of the public peace, health, or safety.
