HB25-1319 be amended as follows, and as so amended, be referred to the Committee on <u>Appropriations</u> with favorable recommendation:

- 13 THAT, IF THE VACANCY OCCURS ON OR AFTER JULY 31 OF AN
- 14 EVEN-NUMBERED YEAR BUT BEFORE BALLOT CONTENT IS CERTIFIED FOR
- 15 THE GENERAL ELECTION HELD IN THAT EVEN-NUMBERED YEAR AND THE
- 16 VACANT SEAT IS SCHEDULED TO BE ON THE BALLOT AT THE GENERAL
- 17 ELECTION HELD IN THAT EVEN-NUMBERED YEAR, THE VACANCY IS FILLED
- 18 AT THAT GENERAL ELECTION ACCORDING TO LAW.".
- 19 Page 6, line 2, after "NEXT" insert "REGULARLY SCHEDULED".
- Page 6, line 6, strike "WHO" and substitute "WHO, AS OF ONE YEAR PRIOR
- 21 TO THE DATE OF THE COUNTY COMMISSIONER VACANCY ELECTION,".

- 1 Page 6, line 7, after "AND" insert "RESIDENTS".
- 2 Page 6, strike lines 14 through 18 and substitute:
- 3 "(c) A CANDIDATE FOR A COUNTY COMMISSIONER VACANCY
- 4 ELECTION IS ELIGIBLE TO BE PLACED ON THE BALLOT IF THE CANDIDATE:".
- 5 Page 6, lines 25 through 27, strike "AT LEAST SEVENTY-FIVE DAYS PRIOR

- 12 (8) OF THIS SECTION; EXCEPT THAT THE PROVISIONS OF PART 9 OF ARTICLE
- 4 OF THIS TITLE 1 THAT CONFLICT WITH THE REQUIREMENTS OR TIMELINE
- 14 DESCRIBED IN THIS SECTION DO NOT APPLY TO PETITIONS SUBMITTED
- 15 PURSUANT TO SUBSECTION (8) OF THIS SECTION. PETITIONS MUST NOT BE
- 16 CIRCULATED AND SIGNATURES MUST NOT BE OBTAINED PRIOR TO THE
- 17 FIRST BUSINESS DAY AFTER THE EFFECTIVE DATE OF THE VACANCY. A
- 18 PETITION MUST NOT BE CIRCULATED UNTIL IT HAS BEEN APPROVED AS
- 19 MEETING THE REQUIREMENTS OF SECTION 1-4-904 AS TO FORM. THE
- 20 COUNTY CLERK AND RECORDER SHALL APPROVE OR DISAPPROVE A
- 21 PETITION AS TO FORM NO LATER THAN THE CLOSE OF THE SECOND
- 22 BUSINESS DAY FOLLOWING SUBMISSION OF THE PROPOSED PETITION.".

- Page 7, line 8, strike "PARTY'S" and substitute "PARTY COUNTY CHAIR'S".

- 27 PERCENT OF APPLICABLE VACANCY COMMITTEE MEMBER SIGNATURES

- Page 8, lines 9 and 10, strike "LATER SIGNATURE DOES NOT COUNT" and

- 1 substitute "SIGNATURE ONLY COUNTS".
- 2 Page 8, strike line 12 and substitute "SECTION ON THE FIRST PETITION
- 3 SUBMITTED THAT CONTAINS THE SIGNATURE.".
- 4 Page 8, lines 15 and 16, strike "VOTERS WHO RESIDE IN THE SAME

- 13 ELECTION DESCRIBED IN SUBSECTION (8)(a) OF THIS SECTION HELD IN
- 14 NOVEMBER OF AN ODD-NUMBERED YEAR, WHICH MAY BE PART OF A
- 15 COORDINATED ELECTION, AND WHICH IS HELD FOR THE PURPOSE OF
- 16 FILLING A VACANCY IN AN UNEXPIRED TERM OF THE OFFICE OF COUNTY
- 17 COMMISSIONER WHO WAS AFFILIATED WITH A MAJOR POLITICAL PARTY IN
- 18 A COUNTY WITH A POPULATION OF AT LEAST FIFTY THOUSAND.".

- 27 FROM ANY ONE PERSON THE AGGREGATE CONTRIBUTION LIMIT FOR A
- 28 GENERAL ELECTION AS SPECIFIED IN SUBSECTION (1.5) OF".
- 29 Page 11, strike lines 14 through 16 and substitute "CANDIDATE WHO IS
- 30 RUNNING FOR A COUNTY COMMISSIONER VACANCY ELECTION, AS DEFINED
- 31 IN SECTION 1-12-206(9), MAY EXPEND CONTRIBUTIONS IN ACCORDANCE".
- Page 11, after line 18 insert:

- "**SECTION 6.** In Colorado Revised Statutes, 1-45-108, **amend** (2)(a)(I)(C), (2)(a)(I)(D), and (2)(a)(I)(F) as follows:
- 1-45-108. Disclosure definitions repeal. (2) (a) (I) Except as provided in subsections (2)(a)(V), (2.1), (2.5), (2.7), and (6) of this section, such reports that are required to be filed with the secretary of state must be filed:
- (C) On the first day of each month beginning the sixth full month before the major election; except that no monthly report shall be required on the first day of the month in which the major election OR COUNTY COMMISSIONER VACANCY ELECTION, AS DEFINED IN SECTION 1-12-206(9), is held:
- (D) On the first Monday in September and on each Monday every two weeks thereafter before the major election OR COUNTY COMMISSIONER VACANCY ELECTION, AS DEFINED IN SECTION 1-12-206(9);
- 15 (F) Fourteen days before and thirty days after a special legislative 16 election OR COUNTY COMMISSIONER VACANCY ELECTION, AS DEFINED IN 17 SECTION 1-12-206 (9), held in an off-election year.".
- 18 Renumber succeeding section accordingly.
- 19 Strike "AS DESCRIBED IN SECTION 1-12-206 (8)(a)" and substitute "AS
- 20 DEFINED IN SECTION 1-12-206 (9)" on: **Page 4**, lines 4 and 15 and 16.
- 21 Strike "DESCRIBED IN SUBSECTION (8)(a) OF THIS SECTION" on: Page 6,
- 22 lines 5 and 6; and **Page 9**, lines 13 and 17 and 18.
- 23 Strike "AS DESCRIBED IN SUBSECTION (8)(a) OF THIS SECTION" on: Page
- 24 **8,** lines 14 and 15 and 24.
