Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB21-106 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation and with a recommendation that it be placed on the consent calendar:

- 1 Amend printed bill, page 7, after line 11 insert:
- 2 "(2) "DEPARTMENT OF EDUCATION" MEANS THE DEPARTMENT OF EDUCATION CREATED IN SECTION 24-1-115.".
- 4 Rerumber succeeding subsections accordingly.
- 5 Page 7, lines 26 and 27, strike "A PRIVATE INSTITUTION OF HIGHER EDUCATION, AS DEFINED IN SECTION 23-18-102 (9);".
- 7 Page 9, strike line 12 and substitute "THE 2021-22 BUDGET YEAR; OR".
- 8 Page 9, strike line 20 and substitute "2021-22 BUDGET YEAR; OR".
- 9 Page 9, strike lines 23 and 24 and substitute "OF THIS SECTION, "THE AVERAGE STATE SHARE OF THE STATE AVERAGE PER-PUPIL REVENUES FOR THE 2021-22 BUDGET YEAR" IS THE AMOUNT CALCULATED DURING THE 2021 REGULAR LEGISLATIVE SESSION.".
- 13 Page 10, line 10, strike "STATE BOARD" and substitute "COMMISSION".
- 14 Page 10, strike lines 22 through 27 and substitute:



1 "(3) (a) NO LATER THAN JULY 1, 2022, AND NO LATER THAN JULY
2 1 EACH YEAR THEREAFTER, THE LOCAL EDUCATION PROVIDER OF A
3 LOW-INCOME STUDENT WHO HAS GRADUATED EARLY DURING THE
4 IMMEDIATELY PRECEDING BUDGET YEAR SHALL NOTIFY THE DEPARTMENT
5 AND THE DEPARTMENT OF EDUCATION OF THE STUDENT'S EARLY
6 GRADUATION, THE NAME OF THE HIGH SCHOOL, AND THE GRADUATION
7 DATE. THE LOCAL EDUCATION PROVIDER SHALL NOTIFY THE DEPARTMENT
8 AND THE DEPARTMENT OF EDUCATION IF THERE IS A CORRECTION TO THE
9 INFORMATION PROVIDED PURSUANT TO THIS SUBSECTION (3)(a).".

10 Page 11, strike lines 1 through 7.

11 Page 11, lines 12 and 13, strike "EQUAL TO" and substitute "SUFFICIENT
12 FOR PAYMENT OF".

13 Page 11, line 15, after "DEPARTMENT" insert "OF EDUCATION".

14 Page 11, line 16, strike "EQUAL TO" and substitute "SUFFICIENT FOR
15 PAYMENT OF".

16 Page 11, line 18, strike "THE APPLICABLE BUDGET YEAR" and substitute
17 "THE 2021-22 BUDGET YEAR, AS CALCULATED DURING THE 2021 REGULAR
18 LEGISLATIVE SESSION,".

19 Page 12, line 23, strike "RULES" and substitute "POLICIES".

20 Page 13, line 14, strike "JOINT BUDGET COMMITTEE AND TO" and
21 substitute "DEPARTMENT OF EDUCATION, THE GOVERNOR'S OFFICE OF
22 STATE PLANNING AND BUDGETING, THE JOINT BUDGET COMMITTEE, AND".

23 Page 13, line 16, strike "MINIMUM:" and substitute "MINIMUM, THE
24 FOLLOWING DATA AND INFORMATION, AS APPLICABLE:".

25 Page 14, line 2, after "THE" insert "NUMBER OF STUDENTS WHO HAVE
26 REQUESTED STATE FUNDING FOR THE CURRENT BUDGET YEAR PRIOR TO
27 THE DATE OF THE REPORT, THE TOTAL AMOUNT OF STATE FUNDING
28 REQUESTED, THE ESTIMATED TOTAL EXPENDITURES FROM THE FUND IN THE
29 CURRENT BUDGET YEAR, AND THE".

30 Page 14, line 3, strike "APPLICABLE" and substitute "CURRENT" and strike
31 "AND".

1 Page 14, line 7, strike "ANY." and substitute "ANY; AND".

2 Page 14, after line 7 insert:

3 **"(h) OUTCOMES AND DATA DESCRIBED IN SUBSECTION (3) OF THIS**
4 **SECTION FOR ELIGIBLE GRADUATES WHO RECEIVED STATE FUNDING.".**

5 Page 15, before line 7 insert:

6 **"SECTION 6. Appropriation.** (1) For the 2021-22 state fiscal
7 year, \$220,115 is appropriated to the department of education. This
8 appropriation is from the general fund and is based on the assumption that
9 the department will require an additional 0.3 FTE. To implement this act,
10 the department may use this appropriation for the high school innovative
11 learning pilot program.

12 (2) For the 2021-22 state fiscal year, \$44,222 is appropriated to
13 the department of higher education. This appropriation is from the general
14 fund, and is based on an assumption that the department will require an
15 additional 0.6 FTE. To implement this act, the department may use this
16 appropriation for the fourth-year innovation pilot program.".

17 Renumber succeeding section accordingly.

18 Page 1, line 102, strike "TRAINING." and substitute "**TRAINING, AND, IN**
19 **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**".
