Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2021-22 based on the March 2021 Legislative Council Staff revenue forecast. The budget package includes a set aside of \$48.0 million General Fund for bills that require General Fund appropriations for FY 2021-22. This bill requires a General Fund appropriation of \$86,483 for FY 2021-22, reducing the \$48.0 million set aside by the same amount.

Future Fiscal Impact

The cost of the bill is expected to increase to \$313,901 total funds, including \$144,710 General Fund, in FY 2022-23 and \$506,536 total funds, including \$233,579 General Fund, in FY 2023-24.
