"(2) The office of a director shall become BECOMES vacant when the director ceases to reside in the county or ground water management district from which the director was appointed, or in the case of COLORADO OR WITHIN A COUNTY THAT IS, IN WHOLE OR IN PART, WITHIN THE BOUNDARIES OF THE DISTRICT, OR WHEN THE DIRECTOR NO LONGER OWNS REAL PROPERTY THAT IS WITHIN THE BOUNDARIES OF THE DISTRICT AND WITHIN THE COUNTY OR GROUND WATER MANAGEMENT DISTRICT FROM WHICH THE DIRECTOR IS APPOINTED. The OFFICE OF A director appointed by the Colorado ground water commission BECOMES VACANT when the director ceases to reside in the district or is no longer a member of the Colorado ground water commission or when declared vacant by a majority vote of all of the members of the board when a director has failed to attend two consecutive regular meetings without having been excused from attendance by the president. If a vacancy occurs in the office by reason of death, resignation, removal, or otherwise, it shall be filled for the remainder of the unexpired term by the board of county commissioners of the county, or the ground water management district from which the director was originally appointed. Each director shall take an oath or affirmation in accordance with section 24-12-101.".
