101	CONCERNING A REQUIREMENT THAT ANY BILL THAT IMPOSES,
102	INCREASES, OR AUTHORIZES THE IMPOSITION OF A FEE BE
103	APPROVED BY A TWO-THIRDS VOTE OF ALL MEMBERS ELECTED
104	TO EACH HOUSE OF THE GENERAL ASSEMBLY TO BECOME LAW.

### **Bill Summary**

The bill creates a requirement that any bill that imposes a new fee, authorizes the imposition of a new fee, increases an existing fee, or authorizes the increase of an existing fee be approved by a two-thirds vote

of all members elected to each house of the general assembly to become law. The two-thirds vote requirement applies only to the vote on final passage of such a bill in each house of the general assembly.

The bill defines a "fee" as a charge that is levied to defray the cost of the particular government service provided to those charged and not levied for the purpose of raising any revenue for a general public purpose.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, add part 21 to article 3 2 of title 2 as follows: 4 **PART 21** 5 VOTING REQUIREMENT FOR NEW OR INCREASED FEES 6 **2-2-2101. Definitions.** AS USED IN THIS PART 21: 7 (1) "FEE" MEANS A CHARGE THAT IS: 8 (a) LEVIED TO DEFRAY THE COST OF THE PARTICULAR 9 GOVERNMENT SERVICE PROVIDED TO THOSE CHARGED; AND 10 (b) NOT LEVIED FOR THE PURPOSE OF RAISING ANY REVENUE FOR 11 A GENERAL PUBLIC PURPOSE. 12 2-2-2102. New fee - increased fee - voting requirements. No 13 BILL THAT IMPOSES A NEW FEE, AUTHORIZES THE IMPOSITION OF A NEW 14 FEE, INCREASES AN EXISTING FEE, OR AUTHORIZES THE INCREASE OF AN 15 EXISTING FEE SHALL BECOME LAW EXCEPT BY A VOTE OF TWO-THIRDS OF 16 ALL MEMBERS ELECTED TO EACH HOUSE OF THE GENERAL ASSEMBLY. THIS 17 SECTION APPLIES ONLY TO THE VOTE ON FINAL PASSAGE OF THE BILL IN 18 EACH HOUSE OF THE GENERAL ASSEMBLY. 19 **SECTION 2.** Act subject to petition - effective date. This act 20 takes effect at 12:01 a.m. on the day following the expiration of the 21 ninety-day period after final adjournment of the general assembly; except 22 that, if a referendum petition is filed pursuant to section 1 (3) of article V
