101     **CONCERNING THE OVERSIGHT AUTHORITY OF THE HEALTH INSURANCE**  
102           **EXCHANGE OVERSIGHT COMMITTEE WITH REGARD TO POLICIES**

The bill gives the health insurance exchange oversight committee (committee) oversight over rules and policies proposed by the health benefit exchange that affect bidding and awarding contracts, carrier and

regulating carrier participation, regulating broker participation and compensation, interacting with other state agencies, managing and compensating the assistance network, or the handling of any type of appeal. The exchange is required to hold a public meeting for a proposed rule or policy and allow for public participation and comment. A committee member may request that the exchange present a rule or policy to the committee, and the committee may repeal the rule or policy by a majority vote.

The committee has the authority to review rules and policies implemented and contracts entered into on or after January 1, 2015.

1       *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 10-22-106, **amend**

3       (1) (d); and **add** (5) as follows:

4           **10-22-106. Powers and duties of the board.** (1) The board is the  
5       governing body of the exchange and has all the powers and duties  
6       necessary to implement this article. The board shall:

7           (d) Create technical and advisory groups ~~as needed~~ TO OPERATE  
8       ON AN ONGOING BASIS AND to report to the board AND PROVIDE GUIDANCE  
9       AT THE DIRECTION OF THE BOARD ON ISSUES THAT DIRECTLY OR  
10      INDIRECTLY AFFECT CONSUMERS. THE BOARD SHALL USE REASONABLE  
11      EFFORTS TO ENSURE THAT THE TECHNICAL AND ADVISORY GROUPS  
12      REFLECT GEOGRAPHIC DIVERSITY AND DIVERSE OPINIONS ON ISSUES  
13      AFFECTING CONSUMERS. The TECHNICAL AND ~~advisory~~ groups shall meet  
14      regularly AT LEAST QUARTERLY throughout the year to discuss issues  
15      related to the exchange and make recommendations to the board; EXCEPT  
16      THAT, BEGINNING TWO YEARS AFTER THE EFFECTIVE DATE OF THIS  
17      PARAGRAPH (d), THE GROUPS SHALL MEET ONLY AS NECESSARY.

18           (5) (a) THE BOARD, WITH PUBLIC INPUT, SHALL SET A POLICY THAT  
19      MAKES CLEAR WHICH ACTIONS BY THE EXCHANGE REQUIRE PUBLIC  
20      SCRUTINY AND SHALL MAKE THE POLICY AVAILABLE TO THE COMMITTEE.

1 IN DETERMINING WHICH ACTIONS REQUIRE PUBLIC SCRUTINY, THE BOARD  
2 SHALL CONSIDER THE EFFECTS THE EXCHANGE'S ACTIONS HAVE ON  
3 CONSUMERS.

4 (b) PRIOR TO TAKING AN ACTION THAT REQUIRES PUBLIC  
5 SCRUTINY, THE EXCHANGE SHALL POST NOTICE OF THE PLANNED ACTION  
6 ON THE EXCHANGE WEBSITE AT LEAST THREE WEEKS PRIOR TO THE DATE  
7 OF THE BOARD MEETING AT WHICH THE ACTION WILL BE DISCUSSED. THE  
8 EXCHANGE SHALL PROVIDE TIME FOR PUBLIC COMMENTS AND QUESTIONS  
9 AT THE BOARD MEETING AND POST THE FINAL ACTION ON THE EXCHANGE  
10 WEBSITE.

11 (c) THE BOARD MAY ADOPT AN ACTION WITHOUT COMPLIANCE  
12 WITH PARAGRAPH (b) OF THIS SUBSECTION (5) IF THE BOARD FINDS THAT  
13 IMMEDIATE ADOPTION IS NECESSARY TO AVOID DISRUPTION OF THE  
14 CONTINUING OPERATION OF THE EXCHANGE. THE EXCHANGE SHALL MAKE  
15 THE ACTION AND THE REASONS FOR THE ACTION AVAILABLE TO THE  
16 PUBLIC AND THE COMMITTEE.

17 **SECTION 2.** In Colorado Revised Statutes, 10-22-107, amend  
18 (7) as follows:

19 **10-22-107. Colorado health insurance exchange oversight**  
20 **committee - creation - duties.** (7) The board shall send the committee  
21 an annual report that contains the financial and operational plans of the  
22 exchange ~~AND THE MAJOR ACTIONS TAKEN BY THE BOARD, PARTICULARLY~~  
23 ~~ACTIONS THAT AFFECT CONSUMERS.~~ The committee shall review the  
24 financial and operational plans of the exchange ~~AND THE MAJOR ACTIONS~~  
25 ~~TAKEN BY THE BOARD.~~

26 **SECTION 3. Effective date.** This act takes effect June 1, 2016.

27 **SECTION 4. Safety clause.** The general assembly hereby finds,

1      determines, and declares that this act is necessary for the immediate  
2      preservation of the public peace, health, and safety.
