After consideration on the merits, the Committee recommends the following:

SB21-064 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend reengrossed bill, page 4, after line 12 insert:

2 "SECTION 4. In Colorado Revised Statutes, **add** 17-18-130 as follows:

3 **17-18-130. Appropriation to comply with section 2-2-703 - S.B.**
4 **21-064 - repeal.** (1) PURSUANT TO SECTION 2-2-703, THE FOLLOWING
5 STATUTORY APPROPRIATIONS ARE MADE IN ORDER TO IMPLEMENT SENATE
6 BILL 21-064, ENACTED IN 2021:

7 (a) FOR THE 2021-22 STATE FISCAL YEAR, ONE HUNDRED NINE
8 THOUSAND FOUR HUNDRED SIXTY TWO DOLLARS IS APPROPRIATED FROM
9 THE CAPITAL CONSTRUCTION FUND CREATED IN SECTION 24-75-302, TO
10 THE CORRECTIONS EXPANSION RESERVE FUND CREATED IN SECTION
11 17-1-116.

12 (2) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2026.

13 SECTION 5. In Colorado Revised Statutes, 24-75-302, **add**
14 (2)(mm):

15 **24-75-302. Capital construction fund - capital assessment fees**
16 **- calculation - information technology capital account - repeal.** (2)
17 The controller shall transfer a sum as specified in this subsection (2) from
18 the general fund to the capital construction fund as money becomes
19 available in the general fund during the fiscal year beginning on July 1 of
20 the fiscal year in which the transfer is made. Transfers between funds
21 pursuant to this subsection (2) are not appropriations subject to the
22 limitations of section 24-75-201.1. The amounts transferred pursuant to

1 this subsection (2) are as follows:

2 (kk) On July 1, 2020, two million forty-three thousand seven
3 hundred sixty-eight dollars; and

4 (ll) For the 2020-21 state fiscal year, one million dollars under
5 S.B. 20-003, enacted in 2020; AND

6 (mm) FOR THE 2021-22 FISCAL YEAR, ONE HUNDRED NINE
7 THOUSAND FOUR HUNDRED SIXTY TWO DOLLARS PURSUANT TO S.B.
8 21-064, ENACTED IN 2021.".

9 Renumber succeeding sections accordingly.
