After consideration on the merits, the Committee recommends the following:

HB25-1210 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 4, strike lines 2 through 27.

2 Strike pages 5 through 7 and substitute:

3 **"SECTION 2.** In Colorado Revised Statutes, 22-11-208, **amend**
4 (1)(a) as follows:
5 **22-11-208. Accreditation - annual review - supports and**
6 **interventions - rules.** (1) (a) The department shall annually review each
7 school district's and the institute's performance and, based on the rules of
8 the state board, determine the appropriate accreditation category for the
9 school district or institute. The department shall notify each school district
10 and the institute of its accreditation category and shall publish each
11 school district's and the institute's accreditation category, with supporting
12 data, on the data portal. The department shall also publish each school
13 district's and the institute's performance, improvement, priority
14 improvement, or turnaround plan, whichever is applicable, on the data
15 portal following adoption of the plan. THE DEPARTMENT SHALL DEVELOP
16 A STREAMLINED FORMAT FOR PLANS THAT CONSOLIDATES VARIOUS STATE,
17 FEDERAL, AND GRANT REPORTING REQUIREMENTS AND ALLOWS A SCHOOL
18 DISTRICT OR THE INSTITUTE TO ATTACH A LOCALLY-DEVELOPED ACTION
19 PORTION OF THE PLAN THAT ADDRESSES ACTION STEPS, RESOURCES, AND
20 ANY OTHER PLAN COMPONENTS IDENTIFIED IN STATE BOARD RULE. THE
21 DEPARTMENT SHALL MAINTAIN A CENTRALIZED SYSTEM FOR PLAN
22 SUBMISSIONS SO THE DEPARTMENT CAN CONDUCT A STATEWIDE ANALYSIS
23 OF SCHOOL DISTRICT AND INSTITUTE PLANS IN ORDER TO DETERMINE HOW
24 TO BEST DISTRIBUTE STATE RESOURCES AND SUPPORTS. ON OR BEFORE
25 AUGUST 1, 2025, AND REGULARLY THEREAFTER, THE DEPARTMENT MUST
26 COLLECT USER FEEDBACK TO ASSESS THE EXTENT TO WHICH THE

1 STREAMLINED FORMAT FOR PLANS IS USED, WHETHER IT IS HELPFUL, AND
2 HOW TO USE THIS FEEDBACK TO IMPROVE THE CENTRALIZED SYSTEM.

3 **SECTION 3.** In Colorado Revised Statutes, 22-11-210, **amend**
4 (2)(a) as follows:

5 **22-11-210. Public schools - annual review - plans - supports**
6 **and interventions - rules.** (2) (a) The department shall annually review
7 each public school's performance and, based on the rules of the state
8 board, recommend to the state board that the public school shall
9 implement a performance, improvement, priority improvement, or
10 turnaround plan for the coming school year. Based on the department's
11 recommendation, the state board shall notify the local school board for
12 the public school, or the institute if the public school is an institute charter
13 school, regarding the type of plan the public school shall implement. The
14 local school board or the institute shall place the public school in the
15 district or institute accreditation category that correlates to the public
16 school's plan, based on the school district's or institute's school
17 accreditation process. THE DEPARTMENT SHALL DEVELOP A STREAMLINED
18 FORMAT FOR PLANS THAT CONSOLIDATES VARIOUS STATE, FEDERAL, AND
19 GRANT REPORTING REQUIREMENTS AND ALLOWS A LOCAL SCHOOL BOARD
20 FOR THE PUBLIC SCHOOL, OR THE INSTITUTE IF THE PUBLIC SCHOOL IS AN
21 INSTITUTE CHARTER SCHOOL, TO ATTACH A LOCALLY-DEVELOPED ACTION
22 PORTION OF THE PLAN THAT ADDRESSES ACTION STEPS, RESOURCES, AND
23 ANY OTHER PLAN COMPONENTS IDENTIFIED IN STATE BOARD RULE. THE
24 DEPARTMENT SHALL MAINTAIN A CENTRALIZED SYSTEM FOR PLAN
25 SUBMISSIONS SO THE DEPARTMENT CAN CONDUCT A STATEWIDE ANALYSIS
26 OF PUBLIC SCHOOL PLANS IN ORDER TO DETERMINE HOW TO BEST
27 DISTRIBUTE STATE RESOURCES AND SUPPORTS. ON OR BEFORE AUGUST 1,
28 2025, AND REGULARLY THEREAFTER, THE DEPARTMENT MUST COLLECT
29 USER FEEDBACK TO ASSESS THE EXTENT TO WHICH THE STREAMLINED
30 FORMAT FOR PLANS IS USED, WHETHER IT IS HELPFUL, AND HOW TO USE
31 THIS FEEDBACK TO IMPROVE THE CENTRALIZED SYSTEM."
