33 *The Secretary of the Senate and the Chief Clerk of the House of
34 Representatives are authorized to hire Legislative Aides pursuant to Joint
35 Rule 39 of the House of Representatives and the Senate. If Legislative
36 Aides are authorized by the Executive Committee, acting in accordance
37 with such Joint Rule 39, to start prior to the convening of the next regular

1 session, they may be paid at the rate specified in this resolution from the
2 date they are authorized to start.

3 (2) That the Secretary of the Senate and the Chief Clerk of the House
4 of Representatives remain in such capacity after adjournment of the
5 General Assembly *sine die* until the convening of the First Regular
6 Session of the Seventy-first General Assembly in January, 2017.

7 (3) That the Chairman of the Senate Services Committee, with the
8 authorization of the President, and the Chairman of the House Services
9 Committee, with the authorization of the Speaker, are hereby separately
10 authorized to retain and hire replacements for such employees for such
11 period of time in the interim between the Second Regular Session of the
12 Seventieth General Assembly and the First Regular Session of the
13 Seventy-First General Assembly as they deem necessary for their
14 respective houses; except that the office equipment of the General
15 Assembly and the services of such employees shall be used only in
16 connection with official legislative business.

17 (4) That the Chairman of the Senate Services Committee, with the
18 authorization of the President, and the Chairman of the House Services
19 Committee, with the authorization of the Speaker, are hereby separately
20 authorized to hire such session-only employees for the next regular
21 session as they deem necessary for their respective houses and who may
22 start their employment on the date authorized.

23 (5) That the officers and the employees referred to in subsections (2)
24 through (4) of this resolution shall be compensated for their services at
25 the rate specified for such positions during the Second Regular Session
26 of this Seventieth General Assembly, as may be modified by any salary
27 survey adjustments and merit increases to become effective during the
28 fiscal year beginning July 1, 2016, which are approved by the President
29 of the Senate for officers and employees of the Senate and the Speaker of
30 the House of Representatives for officers and employees of the House of
31 Representatives. All such compensation shall be paid from moneys
32 appropriated for such purposes by the Seventieth General Assembly.
