Description of Amendments in This Packet

J.001 Staff has prepared amendment **J.001** (attached) to add a provision appropriating \$5,750,000 General Fund to the Department of Higher Education for FY 2022-23. Allocations by institution are shown below.

L.003 and J.002

Bill Sponsor amendment **L.003** (attached):

- Adds provisions specifying that, subject to available appropriation, the Department will enter into limited purpose fee-for-service contracts with public institutions for the Colorado Rural Health-care Workforce Initiative established by this bill.
- Strikes provisions requiring the General Assembly to annually appropriate \$150,000 to the University of Colorado Rural Program Office. Instead requires the Office to receive \$250,000 for FY 2022-23.
- Strikes provisions requiring each of the public institution entities listed to receive a maximum of \$400,000 in FY 2022-23.
- Adds the physician assistant program at the University of Colorado as a recipient program for FY 2022-23.
- Specifies that the Department of Higher Education will allocate money to Colorado Mountain College for FY 2022-23 to establish a rural track in its programs.

Sponsor amendment **J.002** (attached) provides an appropriation of \$5,000,000 General Fund to the Department of Higher Education for FY 2022-23. This includes \$4,750,000 General Fund to the Department's College Opportunity Fund Program for limited purpose fee-for-service contracts with state institutions and \$4,750,000 reappropriated funds to the institutions in the amounts listed below. It also includes \$250,000 General Fund for Colorado Mountain College.

If sponsor amendment L.003 and J.002 are adopted, there is no requirement for funding beyond FY 2022-23, although this could be provided at the discretion of the General Assembly.

The Committee may adopt amendment J.001 OR the combination of amendments L.003 and J.002 but should not adopt any other combination of amendments.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2022-23 based on the March 2022 Legislative Council Staff revenue forecast. The budget package includes two set-asides:

- \$40.0 million General Fund for bills that create ongoing obligations; and
- \$900.0 million General Fund for bills that create one-time obligations in FY 2022-23.

The \$40.0 million *appropriations* set-aside includes an additional \$6.0 million General Fund to provide a 15.0 percent General Fund reserve for those appropriations. The \$900.0 million *obligations* set-aside does not include an additional amount for a General Fund reserve and, assumes, but does not require, that obligations be addressed through statutory transfers rather than appropriations. Therefore *appropriations* from the \$900.0 million set-aside require an additional 15.0 percent to maintain the statutory General Fund reserve.

This bill creates a one-time obligation and requires a General Fund appropriation of \$5.75 million

for FY 2022-23, reducing the \$900.0 million set aside by \$6.6 million in order to maintain a 15.0 percent statutory General Fund reserve. It also requires an ongoing obligation of \$150,000 General Fund. If sponsor amendments L.003 and J.002 are adopted, the bill creates a one-time obligation and requires a General Fund appropriation of \$5.0 million for FY 2022-23, reducing the \$900.0 million set aside by \$5.75 million in order to maintain a 15.0 percent statutory General Fund reserve.
