A BILL FOR AN ACT

CONCERNING PROHIBITING COURTS FROM ORDERING JUVENILES TO PAY RESTITUTION TO INSURANCE COMPANIES.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill prohibits a court from ordering a juvenile to pay restitution to insurance companies. A court may still order restitution for a victim's pecuniary loss for which the victim cannot be compensated under a policy of insurance, self-insurance, an indemnity agreement, or a risk management fund.

2	SECTION 1. In Colorado Revised Statutes, 19-2.5-1104, add (3)
3	and (4) as follows:
4	19-2.5-1104. Sentencing - restitution by juvenile.
5	(3) Notwithstanding section 18-1.3-602 (4)(a)(III) or any other
6	PROVISION OF LAW, A COURT SHALL NOT ORDER A JUVENILE TO PAY
7	RESTITUTION TO AN INSURANCE COMPANY. A COURT MAY ORDER A
8	JUVENILE TO PAY RESTITUTION TO A VICTIM FOR THE PORTION OF A
9	VICTIM'S PECUNIARY LOSS FOR WHICH THE VICTIM CANNOT BE
10	COMPENSATED UNDER A POLICY OF INSURANCE, SELF-INSURANCE, AN
11	INDEMNITY AGREEMENT, OR A RISK MANAGEMENT FUND.
12	(4) AS USED IN THIS SECTION, "VICTIM" DOES NOT MEAN AN
13	INSURANCE COMPANY, AS DEFINED IN SECTION 38-13-102 (13), FOR
14	PURPOSES OF RESTITUTION IN JUVENILE CASES.
15	SECTION 2. Safety clause. The general assembly hereby finds,
16	determines, and declares that this act is necessary for the immediate
17	preservation of the public peace, health, or safety.
