Bill Summary

The bill allows a professional nurse to delegate to another person, after appropriate training, the dispensing authority of an over-the-counter medication to a minor with the signed consent of the minor's parent or guardian.

5	(1) THIS PART 1 DOES NOT PROHIBIT A PERSON WHO HAS BEEN
6	APPROPRIATELY TRAINED FROM DISPENSING AN OVER-THE-COUNTER
7	MEDICATION TO A MINOR AS LONG AS THE PERSON HAS WRITTEN
8	INSTRUCTIONS FROM THE MINOR'S PARENT OR GUARDIAN AND THERE IS A
9	PHYSICIAN'S STANDING MEDICAL ORDER.
10	(2) This section is not intended to affect the authority of
11	A PROFESSIONAL NURSE TO DELEGATE NURSING TASKS.
12	SECTION 2. Act subject to petition - effective date. This act
13	takes effect at 12:01 a.m. on the day following the expiration of the
14	ninety-day period after final adjournment of the general assembly (August
15	9, 2017, if adjournment sine die is on May 10, 2017); except that, if a
16	referendum petition is filed pursuant to section 1 (3) of article V of the
17	state constitution against this act or an item, section, or part of this act
18	within such period, then the act, item, section, or part will not take effect
19	unless approved by the people at the general election to be held in
20	November 2018 and, in such case, will take effect on the date of the
21	official declaration of the vote thereon by the governor.
