(4.8) The state treasurer shall transfer 6 from the fund to the public school capital construction assistance fund created in section 22-43.7-104: 7 8 (c) Twenty million dollars on June 1, 2024 JUNE 1, 2026. 9 **SECTION 2.** Appropriation - adjustments to 2024 long bill. To 10 implement this act, the cash funds appropriation from the public school 11 capital construction assistance fund created in section 22-43.7-104 (1), 12 C.R.S., made in the annual general appropriation act for the 2024-25 state 13 fiscal year to the department of education for public school capital 14 construction assistance board cash grants, is decreased by \$20,000,000. 15 SECTION 3. Safety clause. The general assembly finds, 16 determines, and declares that this act is necessary for the immediate 17 preservation of the public peace, health, or safety or for appropriations for 18 the support and maintenance of the departments of the state and state 19 institutions.
