After consideration on the merits, the Committee recommends the following:

SB25-072 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend reengrossed bill, page 2, after line 1 insert:
- 2 **"SECTION 1. Short title.** The short title of this act is the "Daniel
- 3 Bregger Act".
- 4 Renumber succeeding sections accordingly.
- 5 Page 3, strike lines 24 through 27 and substitute "SPECIOSA PLANT, IN
- 6 FRESH, DEHYDRATED, OR DRIED FORM".
- 7 Page 4, strike lines 1 through 3.
- 8 Page 4, lines 10 and 11, strike "KRATOM LEAF OR KRATOM LEAF EXTRACT"
- 9 and substitute "ANY PART OF A KRATOM LEAF, A KRATOM LEAF EXTRACT,
- 10 OR ANY KRATOM ALKALOID, KRATOM CONSTITUENT, OR KRATOM
- 11 METABOLITE".
- 12 Page 4, line 13, after "(9)" insert "(a)".
- 13 Page 4, after line 16 insert:
- 14 **"(b) "PROCESSOR" DOES NOT INCLUDE A FACILITY THAT PREPARES**
- 15 **A KRATOM PRODUCT ON SITE AND OFFERS THE KRATOM PRODUCT FOR SALE**
- 16 **AT THE PREPARATION SITE".**
- 17 Page 5, strike lines 19 and 20.
- 18 Page 5, line 21, strike "ORGANIZATION," and substitute "CERTIFICATE

1 FROM A THIRD-PARTY, INDEPENDENT AUDITOR, INDICATING THAT THE
2 PROCESSOR'S OPERATIONS ARE GENERALLY CONSISTENT WITH THE
3 FEDERAL FOOD AND DRUG ADMINISTRATION'S GOOD MANUFACTURING
4 PRACTICE REQUIREMENTS SPECIFIED IN 21 CFR 111 OR 117, AS
5 APPLICABLE AND AS THOSE PARTS EXISTED ON JULY 1, 2025,".

6 Page 5, line 25, strike "DISTRIBUTES" and substitute "HOLDS".

7 Page 6, line 4, strike "MUST CONFIRM THAT:" and substitute "MUST:".

8 Page 6, line 5, strike "THE" and substitute "CONFIRM THAT THE".

9 Page 6, line 9, strike "THERE" and substitute "INCLUDE A STATEMENT
10 FROM THE PROCESSOR CERTIFYING THAT THERE".

11 Page 7, line 6, after "IS" insert "KNOWINGLY".

12 Page 10, line 3, strike "111, AS THAT PART" and substitute "111 OR 117,
13 AS THOSE PARTS".

14 Page 10, line 5, strike "PROCESSOR" and substitute "PERSON THAT
15 MANUFACTURES, PACKAGES, LABELS, OR HOLDS A KRATOM PRODUCT TO
16 BE DISTRIBUTED IN THE STATE".

17 Page 11, strike lines 13 through 15 and substitute:

18 "(I) THE NAME AND ADDRESS FOR THE PLACE OF BUSINESS OF THE
19 MANUFACTURER OR DISTRIBUTOR OF THE KRATOM PRODUCT;".

20 Page 11, strike line 17 and substitute:

21 "(III) DISCLOSURE AND ADVICE:".

22 Page 11, strike lines 21 through 23 and substitute:

23 "(C) THAT KRATOM MAY BE HABIT FORMING; AND
24 (D) THAT KRATOM MAY INTERACT WITH CERTAIN MEDICATIONS,
25 DRUGS, AND".

26 Renumber succeeding subparagraphs accordingly.

27 Strike "THREE HUNDRED SIX THOUSAND THREE HUNDRED FORTY-FOUR"
28 and substitute "TWO HUNDRED EIGHTY THOUSAND SIX HUNDRED SIX" on:

- 1 **Page 7**, lines 25 and 26; **Page 13**, lines 9 and 10; and **Page 14**, lines 4 and
- 2 5.
