A BILL FOR AN ACT

CONCERNING THE DEVELOPMENT OF MARIJUANA EDUCATION MATERIALS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov/.)

Committee on Cost-benefit Analysis of Legalized Marijuana in Colorado. The bill directs the department of education:

- By July 1, 2017, to create and maintain a resource bank for public schools to use without charge that consists of materials and curricula pertaining to marijuana use; and
- ! Upon request of a public school, to provide technical

assistance in designing age-appropriate curricula on marijuana use.

The bill authorizes resource bank expenses to be paid from the marijuana tax cash fund.

1	Be it enacted by the General Assembly of the State of Colorado:
2	SECTION 1. In Colorado Revised Statutes, add 22-2-127.5 as
3	follows:
4	22-2-127.5. Marijuana education materials - resource bank -
5	technical assistance. (1) The Department, with assistance from the
6	DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT, SHALL CREATE AND
7	MAINTAIN A RESOURCE BANK OF MATERIALS AND CURRICULA PERTAINING
8	TO MARIJUANA, WHICH MATERIALS AND CURRICULA MAY BE USED IN
9	ELEMENTARY AND SECONDARY SCHOOLS IN THE STATE. THE DEPARTMENT
10	MAY CONTRACT FOR SERVICES TO SUPPORT THE MAINTENANCE OF THE
11	RESOURCE BANK AND DEVELOPMENT OF THE CURRICULA.
12	(2) On and after July 1, 2017, the department shall make
13	MATERIAL IN THE RESOURCE BANK AVAILABLE WITHOUT CHARGE TO
14	SCHOOL DISTRICTS, CHARTER SCHOOLS, AND BOARDS OF COOPERATIVE
15	SERVICES. AT THE REQUEST OF A SCHOOL DISTRICT, CHARTER SCHOOL, OR
16	BOARD OF COOPERATIVE SERVICES, THE DEPARTMENT SHALL PROVIDE
17	TECHNICAL ASSISTANCE TO THE SCHOOL DISTRICT, CHARTER SCHOOL, OR
18	BOARD OF COOPERATIVE SERVICES IN DESIGNING AGE-APPROPRIATE
19	CURRICULA PERTAINING TO MARIJUANA USE.
20	SECTION 2. In Colorado Revised Statutes, 39-28.8-501, amend
