A BILL FOR AN ACT

101 **CONCERNING VEHICLE TRANSACTIONS FOR DEPLOYED MILITARY**
102 **FAMILIES.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. In current law, if a service member's driver's license expires while they are serving on active duty outside of Colorado, the driver's license expiration date is extended for 3 years or until 90 days after the service member returns to the state. The bill designates the service member's dependents as also subject to the extension of their driver's license expiration date.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 42-2-118, **amend** (2);
3 and **add** (6) as follows:

4 **42-2-118. Renewal of license in person, by mail, or**
5 **electronically - donations to Emily Keyes - John W. Buckner organ**
6 **and tissue donation awareness fund - rules - report - definitions -**
7 **repeal.** (2) Every license referred to in this section which is at the time
8 of its expiration, as provided in subsection (1) of this section, held by a
9 SERVICE member, ~~of the armed forces of the United States~~, then serving
10 on active duty outside of this state, ~~shall~~ OR THEIR DEPENDENT, DOES not
11 expire as provided in subsection (1) of this section, but ~~such~~ THE
12 expiration date ~~shall be~~ IS extended for ~~a period of~~ three years or until
13 ninety days after ~~such~~ THE licensee returns to this state, whichever occurs
14 first.

15 (6) AS USED IN THIS SECTION:

16 (a) "DEPENDENT" MEANS:

17 (I) A SERVICE MEMBER'S SPOUSE;

18 (II) A SERVICE MEMBER'S CHILD; AND

19 (III) AN INDIVIDUAL FOR WHOM A SERVICE MEMBER HAS PROVIDED
20 MORE THAN ONE-HALF OF THE INDIVIDUAL'S SUPPORT FOR AT LEAST ONE
21 HUNDRED EIGHTY DAYS IMMEDIATELY PRECEDING THE EXPIRATION OF A
22 LICENSE REFERRED TO IN THIS SECTION.

23 (b) "SERVICE MEMBER" MEANS A MEMBER OF THE UNITED STATES
24 ARMED FORCES.

25 **SECTION 2. Act subject to petition - effective date.** This act
26 takes effect January 1, 2027; except that, if a referendum petition is filed

1 pursuant to section 1 (3) of article V of the state constitution against this
2 act or an item, section, or part of this act within the ninety-day period
3 after final adjournment of the general assembly, then the act, item,
4 section, or part will not take effect unless approved by the people at the
5 general election to be held in November 2026 and, in such case, will take
6 effect January 1, 2027, or on the date of the official declaration of the
7 vote thereon by the governor, whichever is later. [REDACTED]
