Bill Summary

The bill makes it a level 1 drug felony if a person sells, dispenses, distributes, or otherwise transfers any quantity of a controlled substance or any material, compound, mixture, or preparation that contains any amount of a controlled substance and the sale, dispensing, distribution, or transfer is the proximate cause of the death of another person who used

or consumed the controlled substance material, compound, mixture, or preparation.

Be it enacted by the General Assembly of the State of Colorado: 1 2 **SECTION 1.** In Colorado Revised Statutes, 18-18-405, add 3 (2)(a)(IV) as follows: 4 18-18-405. Unlawful distribution, manufacturing, dispensing, 5 or sale. (2) Except as otherwise provided for an offense concerning 6 marijuana and marijuana concentrate in section 18-18-406 and for special 7 offenders as provided in section 18-18-407, any person who violates any 8 of the provisions of subsection (1) of this section: 9 (a) Commits a level 1 drug felony and is subject to the mandatory 10 sentencing provisions in section 18-1.3-401.5 (7) if: 11 (IV) THE PERSON SELLS, DISPENSES, DISTRIBUTES, OR OTHERWISE 12 TRANSFERS ANY QUANTITY OF A CONTROLLED SUBSTANCE OR ANY 13 MATERIAL, COMPOUND, MIXTURE, OR PREPARATION THAT CONTAINS ANY 14 AMOUNT OF A CONTROLLED SUBSTANCE AND THE SALE, DISPENSING, 15 DISTRIBUTION, OR TRANSFER IS THE PROXIMATE CAUSE OF THE DEATH OF 16 ANOTHER PERSON WHO USED OR CONSUMED THE CONTROLLED SUBSTANCE 17 MATERIAL, COMPOUND, MIXTURE, OR PREPARATION. 18 SECTION 2. Act subject to petition - effective date -19 **applicability.** (1) This act takes effect at 12:01 a.m. on the day following 20 the expiration of the ninety-day period after final adjournment of the 21 general assembly; except that, if a referendum petition is filed pursuant 22 to section 1 (3) of article V of the state constitution against this act or an 23 item, section, or part of this act within such period, then the act, item, 24 section, or part will not take effect unless approved by the people at the 25 general election to be held in November 2024 and, in such case, will take
