2                   **the fiscal year beginning July 1, 2020.** In Session Laws of Colorado  
3                   2021, **amend** section 15 (1) and (2) of chapter 371, (HB 21-1289), as  
4                   section 15 (1) and (2) are amended by section 2 of chapter 493 (HB  
5                   22-1172), Session Laws of Colorado 2022, and as section 15 (1) is  
6                   amended by section 2 of SB 23-116, as follows:

7                   Section 15. **Appropriations.** (1) For the 2020-21 state fiscal year,  
8                   \$27,000,000 is appropriated to the office of the governor for use by the  
9                   office of information technology for use by the Colorado broadband  
10                  office. This appropriation is from the digital inclusion grant program fund  
11                  created in section 24-37.5-904 (2), C.R.S., and of money the state  
12                  received from the federal coronavirus state fiscal recovery fund. The  
13                  Colorado broadband office may use this appropriation to implement the  
14                  digital inclusion grant program created in section 24-37.5-904 (1)(a),  
15                  C.R.S. ~~Any money appropriated in this subsection (1) not expended prior~~  
16                  ~~to July 1, 2022, is further appropriated to the office of the governor for~~  
17                  ~~use by the office of information technology for the 2022-23 state fiscal~~  
18                  ~~year for the same purpose.~~ ANY MONEY APPROPRIATED IN THIS  
19                  SUBSECTION THAT ORIGINATED FROM MONEY THE STATE RECEIVED FROM

8 from the broadband stimulus account in the broadband administrative  
9 fund created in section 24-37.5-119 (4), C.R.S., and of money the state  
10 received from the federal coronavirus state fiscal recovery fund. The  
11 broadband deployment board may use this appropriation to implement the  
12 broadband stimulus grant program created in section 24-37.5-119 (9.5),  
13 C.R.S. ~~Any money appropriated in this subsection (2) not expended prior~~  
14 ~~to July 1, 2022, is further appropriated to the office of the governor for~~  
15 ~~use by the office of information technology for the 2022-23 state fiscal~~  
16 ~~year for the same purpose.~~ ANY MONEY APPROPRIATED IN THIS

6 section 15 (3) is amended by section 11 of chapter 507 (HB 22-1329),  
7 Session Laws of Colorado 2022, as follows:

8 Section 15. **Appropriations.** (3) For the 2020-21 state fiscal  
9 year, \$5,000,000 is appropriated to the department of local affairs for use  
10 by the division of local government. This appropriation is from the  
11 interconnectivity grant program fund created in section 24-32-104 (7)(c),  
12 C.R.S., and of money the state received from the federal coronavirus state  
13 fiscal recovery fund. The division of local government may use this  
14 appropriation to implement the interconnectivity grant program created  
15 in section 24-32-104 (7)(a), C.R.S. ~~Any money appropriated in this~~  
16 ~~subsection (3) not expended prior to July 1, 2022, is further appropriated~~  
17 ~~to the department of local affairs for use by the division of local~~  
18 ~~government for the 2022-23 state fiscal year for the same purpose.~~ ANY

9 Section 37. **Appropriation.** (9)(b) Any money appropriated in  
10 this subsection (9) not expended prior to July 1, 2022, is further  
11 appropriated to the office for the 2022-23 state fiscal year for the same  
12 ~~purpose.~~ PURPOSE; AND ANY MONEY APPROPRIATED IN SUBSECTIONS  
13 (9)(a)(II), (9)(a)(VI), AND (9)(a)(VII) IS FURTHER APPROPRIATED TO THE  
14 OFFICE FOR THE 2023-24 STATE FISCAL YEAR FOR THE SAME PURPOSE.

15 (12) For the 2021-22 state fiscal year, \$300,000 is appropriated to  
16 the department of human services for use by the office of the ombudsman  
17 for behavioral health access to care. This appropriation is from the  
18 behavioral and mental health cash fund created in section 24-75-230,  
19 C.R.S., and of money the state received from the federal coronavirus state  
20 fiscal recovery fund. The office may use the appropriation to help resolve  
21 behavioral health-care access and coverage concerns or complaints for

1 consumers and health-care providers. Any money appropriated in this  
2 subsection (12) not expended prior to July 1, 2022, is further appropriated  
3 to the department for the ~~2022-23~~ 2023-24 state fiscal year for the same  
4 purpose.

5 **SECTION 15. Appropriation to the department of early**  
6 **childhood for the fiscal year beginning July 1, 2022.** In Session Laws  
7 of Colorado 2022, **amend** section 8 (2) of chapter 345, (SB 22-213), as  
8 follows:

9 Section 8. **Appropriation.** (2) ~~Any money appropriated in~~

3           Section 2. **Appropriation.** For the 2022-23 state fiscal year,  
4 \$2,000,000 is appropriated to the department of early childhood for use  
5 by the community and family support division. This appropriation is from  
6 the economic recovery and relief cash fund created in section 24-75-228,  
7 C.R.S., is of money the state received from the federal coronavirus state  
8 fiscal recovery fund, and is based on an assumption that the department  
9 will require an additional 0.3 FTE. To implement this act, the division  
10 may use this appropriation for the children's mental health program  
11 authorized in section 26.5-1-113, C.R.S. ~~Any money appropriated in this~~  
12 ~~section not expended prior to July 1, 2023, is further appropriated to the~~  
13 ~~division from July 1, 2023, through December 30, 2024, for the same~~  
14 ~~purpose.~~ ANY MONEY APPROPRIATED IN THIS SECTION THAT ORIGINATED

4                Section 24. **Appropriation.** (1) For the 2022-23 state fiscal year,  
5        ~~\$730,573~~ \$712,009 is appropriated to the department of health care policy  
6        and financing. This appropriation is from the general fund. To implement  
7        this act, the department may use this appropriation as follows:

8                (e) ~~\$18,564 for children's basic health plan medical and dental~~  
9        ~~costs.~~

10              **SECTION 18. Appropriation to the department of health care**  
11        **policy and financing for the fiscal year beginning July 1, 2022.** In  
12        Session Laws of Colorado 2022, **repeal** section 25 (2), of chapter 399,  
13        (HB 22-1289), as follows:

14              Section 25. **Appropriation - adjustments to 2022 long bill.**  
15        (2) ~~For the 2022-23 state fiscal year, \$144,229 is appropriated to the~~  
16        ~~department of health care policy and financing. This appropriation is from~~  
17        ~~the general fund. To implement this act, the department may use this~~

19              **SECTION 19. Appropriation to the department of health care**  
20        **policy and financing for the fiscal year beginning July 1, 2022.** In  
21        Session Laws of Colorado 2022, **amend** section 6 (1) and (2), of chapter

1 180, (HB 22-1302), as follows:

2 Section 6. **Appropriation.** (1) For the 2022-23 state fiscal year,  
3 \$31,750,000 is appropriated to the department of health care policy and  
4 financing for use by other medical services. This appropriation is from the  
5 behavioral and mental health cash fund created in section 24-75-230  
6 (2)(a), C.R.S., is of money the state received from the federal coronavirus  
7 state fiscal recovery fund, and is based on an assumption that the division  
8 will require an additional 2.3 FTE. To implement this act, the division  
9 may use this appropriation for the primary care and behavioral health  
10 statewide integration grant program. ~~Any money appropriated in this~~  
11 ~~section not expended prior to July 1, 2023, is further appropriated to the~~  
12 ~~division from July 1, 2023, through December 30, 2024, for the same~~

7 ~~expended prior to July 1, 2023, is further appropriated to the division~~  
8 ~~from July 1, 2023, through December 30, 2024, for the same purpose.~~

2 FOR THE 2023-24 STATE FISCAL YEAR FOR THE SAME PURPOSE.

3 **SECTION 21. Appropriation to the department of human**  
4 **services for the fiscal year beginning July 1, 2022.** In Session Laws of  
5 Colorado 2022, **amend** section 6 (1), (2), and (3) of chapter 375, (HB  
6 22-1380), as follows:

7 Section 6. **Appropriation.** (1) For the 2022-23 state fiscal year,  
8 \$3,000,000 is appropriated to the department of human services for use  
9 by administration and finance. This appropriation is from the economic  
10 recovery and relief cash fund created in section 24-75-228 (2)(a), C.R.S.,  
11 and is of money the state received from the federal coronavirus state  
12 fiscal recovery fund. To implement this act, administration and finance  
13 may use this appropriation for IT systems interoperability. ANY MONEY  
14 APPROPRIATED IN THIS SECTION NOT EXPENDED PRIOR TO JULY 1, 2023, IS  
15 FURTHER APPROPRIATED TO ADMINISTRATION AND FINANCE FROM JULY 1,  
16 2023, THROUGH DECEMBER 31, 2024, FOR THE SAME PURPOSE.

17 (2) For the 2022-23 state fiscal year, \$2,000,000 is appropriated  
18 to the department of human services for use by the office of economic  
19 security. This appropriation is from the economic recovery and relief cash  
20 fund created in section 24-75-228 (2)(a), C.R.S., and is of money the state  
21 received from the federal coronavirus state fiscal recovery fund. To

1       implement this act, the office of economic security may use this  
2       appropriation for fuel assistance payments related to food and energy  
3       assistance. ANY MONEY APPROPRIATED IN THIS SECTION NOT EXPENDED  
4       PRIOR TO JULY 1, 2023, IS FURTHER APPROPRIATED TO THE OFFICE OF  
5       ECONOMIC SECURITY FROM JULY 1, 2023, THROUGH DECEMBER 31, 2024,  
6       FOR THE SAME PURPOSE.

7               (3) For the 2022-23 state fiscal year, \$1,000,000 is appropriated  
8       to the department of human services for use by the office of economic  
9       security. This appropriation is from the economic recovery and relief cash  
10      fund created in section 24-75-228 (2)(a), C.R.S., and is of money the state  
11      received from the federal coronavirus state fiscal recovery fund. To  
12      implement this act, the office of economic security may use this  
13      appropriation for electronic benefits transfer programming related to food  
14      and energy assistance. ANY MONEY APPROPRIATED IN THIS SECTION NOT  
15      EXPENDED PRIOR TO JULY 1, 2023, IS FURTHER APPROPRIATED TO THE  
16      OFFICE OF ECONOMIC SECURITY FROM JULY 1, 2023, THROUGH DECEMBER  
17      31, 2024, FOR THE SAME PURPOSE.

18               **SECTION 22. Appropriation to the department of personnel**  
19      **for the fiscal year beginning July 1, 2022.** In Session Laws of Colorado  
20      2022, **amend** section 37 (6) of chapter 172, (HB 22-1242), as follows:

21               Section 37. **Appropriation.** (6) For the 2022-23 state fiscal year,

1       \$9,517 is appropriated to the department of personnel. This appropriation  
2       is from reappropriated funds received from the department of ~~local affairs~~  
3       REGULATORY AGENCIES under subsection (5)(c) of this section. To  
4       implement this act, the department of personnel may use this  
5       appropriation to provide vehicles to the department of regulatory  
6       agencies.

7               **SECTION 23. Safety clause.** The general assembly hereby finds,  
8       determines, and declares that this act is necessary for the immediate  
9       preservation of the public peace, health, and safety.
