Section 1 of the bill appropriates \$61,419,806 total funds for the Legislative Department for FY 2022-23, including:

- \$59,794,475 General Fund;
- \$90,000 cash funds; and
- \$1,535,331 reappropriated funds.

This section reflects a total of 421.0 FTE.

Section 2 of the bill appropriates \$50,000 General Fund to the Youth Advisory Council Cash Fund for FY 2022-23. This cash fund is continuously appropriated to the Legislative Department for the costs of the Youth Advisory Council.

Section 3 of the bill authorizes the Legislative Council to spend \$17,500 of its FY 2021-22 General Fund appropriation in FY 2022-23 for new member orientation.

More detailed information about the appropriations for each legislative agency is included in the March 4, 2022 booklet titled, "Colorado Legislative Branch: 2022-23 Fiscal Year Budget Request".
