COLORADO.

WHEREAS, SMA is known to cause degeneration in voluntary muscle movement for those who survive the disease; and

WHEREAS, SMA crosses all racial and ethnic boundaries, affecting people of all ages and genders; and

WHEREAS, Increased awareness about SMA will lead to increased public knowledge and support for both disease research and the families affected by this disease, hopefully leading to a cure; and

WHEREAS, Patient groups have named the month of August as National Spinal Muscular Atrophy Awareness Month in order to raise awareness and promote research of this devastating disease; and

WHEREAS, Organizations working to find an effective treatment and cure for SMA and the families dealing with this disease deserve our support; now, therefore,

Be It Resolved by the Senate of the Seventy-first General Assembly of the State of Colorado, the House of Representatives concurring herein:
