CONCERNING THE EXTENSION OF THE COLORADO STUDENT LEADERS

Bill Summary

The bill extends the Colorado student leaders institute to June 30, 2024.

1 Be it enacted by the General Assembly of the State of Colorado:

1	SECTION 1. In Colorado Revised Statutes, 23-//-103, amend
2	(1) as follows:
3	23-77-103. Colorado student leaders institute - created -
4	applications. (1) There is created in the department of higher education
5	the Colorado student leaders institute. to operate as a pilot program
6	through the summer of 2019. The institute is a competitive residential
7	summer academic program for students who are entering tenth or
8	eleventh grade in the coming fall semester. The institute operates for four
9	weeks each summer during which time students who are accepted to the
10	institute attend college-level classes, lectures, and seminars as well as
11	enrichment activities, including concerts and theatrical productions. Each
12	student who is accepted to the institute is encouraged to donate up to four
13	hundred dollars to the institute to assist in meeting operational costs.
14	Subject to available appropriations, up to one hundred students may
15	annually participate in the institute.
16	SECTION 2. In Colorado Revised Statutes, 23-77-105, amend
17	(2)(b) as follows:
18	23-77-105. Colorado student leaders institute - funding - cash
19	fund created. (2) (b) The money in the cash fund is continuously
20	appropriated to the executive board for the direct and indirect costs
21	incurred in implementing the institute. The state treasurer may invest as
22	provided by law any money in the cash fund that is not expended for the
23	purposes of this article 77. The state treasurer shall credit to the cash fund
24	all interest and income derived from the investment and deposit of money
25	in the cash fund. Any unexpended and unencumbered money remaining
26	in the cash fund at the end of a fiscal year must remain in the cash fund
27	and shall not be credited to another fund; except that the state treasurer

1	shall credit any unexpended and unencumbered money remaining in the
2	fund as of June 30, 2019 June 30, 2024, to the state education fund
3	created in section 17 (4) of article IX of the state constitution.
4	SECTION 3. In Colorado Revised Statutes, amend 23-77-106 as
5	follows:
6	23-77-106. Repeal of article. This article 77 is repealed, effective
7	July 1, 2019 July 1, 2024.
8	SECTION 4. Safety clause. The general assembly hereby finds,
9	determines, and declares that this act is necessary for the immediate
10	preservation of the public peace, health, and safety.
