29 \*The Chief Clerk of the House of Representatives and the Secretary of  
30 the Senate are authorized to hire Legislative Aides pursuant to Joint Rule  
31 39 of the Senate and the House of Representatives. If Legislative Aides  
32 are authorized by the Executive Committee, acting in accordance with  
33 such Joint Rule 39, to start prior to the convening of the next regular  
34 session, they may be paid at the rate specified in this resolution from the  
35 date they are authorized to start.

36 (2) That the Chief Clerk of the House of Representatives and the  
37 Secretary of the Senate remain in such capacity after adjournment of the  
38 General Assembly *sine die* until the convening of the First Regular  
39 Session of the Seventy-sixth General Assembly in January 2027.
