1 *Be It Resolved by the Senate of the Seventy-second General*
2 *Assembly of the State of Colorado, the House of Representatives*
3 *concurring herein:*

5 (1) That, pursuant to the provisions of section 2-2-305, Colorado
6 Revised Statutes, the following positions are hereby created for the
7 Second Regular Session of the Seventy-second General Assembly with
8 the monthly compensation to be paid to the persons elected or appointed
9 to each position in the range set opposite the position:

1 Aides are authorized by the Executive Committee, acting in accordance
2 with such Joint Rule 39, to start prior to the convening of the next regular
3 session, they may be paid at the rate specified in this resolution from the
4 date they are authorized to start.

5 (2) That the Secretary of the Senate and the Chief Clerk of the House
6 of Representatives remain in such capacity after adjournment of the
7 General Assembly *sine die* until the convening of the First Regular
8 Session of the Seventy-third General Assembly in January, 2021.

9 (3) That the President of the Senate and the Chair of the House
10 Services Committee, with the authorization of the Speaker of the House
11 of Representatives, are hereby separately authorized to retain and hire
12 replacements for such employees for such period of time in the interim
13 between the Second Regular Session of the Seventy-second General
14 Assembly and the First Regular Session of the Seventy-third General
15 Assembly as they deem necessary for their respective houses; except that
16 the office equipment of the General Assembly and the services of such
17 employees shall be used only in connection with official legislative
18 business.

19 (4) That the President of the Senate and the Chair of the House
20 Services Committee, with the authorization of the Speaker of the House
21 of Representatives, are hereby separately authorized to hire such
22 session-only employees for the next regular session as they deem
23 necessary for their respective houses and who may start their employment
24 on the date authorized.

25 (5) That the officers and the employees referred to in subsections (2)
26 through (4) of this resolution shall be compensated for their services at
27 the rate specified for such positions during the Second Regular Session
28 of this Seventy-second General Assembly, as may be modified by any
29 salary survey adjustments and merit increases to become effective during
30 the fiscal year beginning July 1, 2020, which are approved by the
31 President of the Senate for officers and employees of the Senate and the
32 Speaker of the House of Representatives for officers and employees of
33 the House of Representatives. All such compensation shall be paid from
34 money appropriated for such purposes by the Seventy-second General
35 Assembly.
