Sunset Process - House Agriculture, Livestock, and Natural Resources Committee. The bill implements the first recommendation

contained in the department of regulatory agencies' sunset report on the division of racing events and the Colorado racing commission within the department of revenue by continuing the division and the Colorado racing commission to 2023.

2	SECTION 1. In Colorado Revised Statutes, amend 12-60-901 as
3	follows:
4	12-60-901. Repeal of article - review of functions. (1) This
5	article is repealed, effective <del>July</del> SEPTEMBER 1, <del>2016</del> 2023. Prior to <del>such</del>
6	THE repeal, the division and its functions shall be reviewed as provided
7	for in section 24-34-104, C.R.S.
8	SECTION 2. In Colorado Revised Statutes, 24-34-104, repeal
9	(47) (b); and <b>add</b> (54) (b) as follows:
10	24-34-104. General assembly review of regulatory agencies
11	and functions for termination, continuation, or reestablishment.
12	(47) The following agencies, functions, or both, shall terminate on July
13	1, 2016:
14	(b) The division of racing events, including the Colorado racing
15	commission created by article 60 of title 12, C.R.S.;
16	(54) The following agencies, functions, or both, terminate on
17	September 1, 2023:
18	(b) THE DIVISION OF RACING EVENTS, INCLUDING THE COLORADO
19	RACING COMMISSION, CREATED BY ARTICLE 60 OF TITLE 12, C.R.S.
20	SECTION 3. Safety clause. The general assembly hereby finds,
21	determines, and declares that this act is necessary for the immediate
22	preservation of the public peace, health, and safety.
