Description of Amendments in This Packet

J.001 Staff has prepared amendment **J.001** (attached) to make technical changes to the appropriation clause to appropriate \$2,515,319 total funds (including \$1,257,660 General Fund and \$1,257,659 federal funds) to the Department of Health Care Policy and Financing for the Children's Habilitation Residential Program in a separate line item rather than adding it to the existing "Children's Extensive Support Services" line item.
