Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB24-1075 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 3, strike lines 6 and 7 and substitute:

2 "(a) "ANALYSIS COLLABORATIVE" MEANS THE STATEWIDE
3 HEALTH-CARE ANALYSIS COLLABORATIVE CREATED PURSUANT TO".

4 Page 8 of the bill, line 3, strike "BY OCTOBER 1, 2025," and substitute
5 "ON OR BEFORE DECEMBER 31, 2025,".

6 Page 8 of the bill, line 6, strike "INSURANCE" and substitute "HUMAN
7 SERVICES".

8 Page 8 of the bill, line 9, after "(6)" insert "(a)".

9 Page 8 of the bill, after line 12 insert:

10 "(b) THE COLORADO SCHOOL OF PUBLIC HEALTH SHALL SUBMIT AN
11 APPLICATION TO THE ALL-PAYER HEALTH CLAIMS DATABASE SCHOLARSHIP
12 GRANT PROGRAM, ESTABLISHED IN SECTION 25.5-1-204.5, TO ACQUIRE
13 FUNDING TO COVER ANY DATA OR SOFTWARE COSTS THAT MAY BE
14 INCURRED BY THE COLORADO SCHOOL OF PUBLIC HEALTH IN CONDUCTING
15 THE ANALYSIS REQUIRED PURSUANT TO SUBSECTION (4) OF THIS SECTION.".

16 Page 8 of the bill, strike lines 19 and 20 and substitute, "COLLABORATIVE,
17 REFERRED TO IN THIS SECTION AS THE "ANALYSIS COLLABORATIVE", FOR
18 THE PURPOSE OF ADVISING THE COLORADO SCHOOL OF".

19 Page 9 of the bill, strike lines 4 and 5 and substitute:

20 "(3)(a) ON OR BEFORE AUGUST 1, 2024, THE EXECUTIVE DIRECTOR
21 OF THE STATE DEPARTMENT SHALL INVITE THE FOLLOWING
22 REPRESENTATIVES TO PARTICIPATE IN THE ANALYSIS COLLABORATIVE:".

1 Page 10 of the bill, strike lines 11 through 13 and substitute:

2 "(b) IN INVITING REPRESENTATIVES TO PARTICIPATE IN THE
3 ANALYSIS COLLABORATIVE PURSUANT TO SUBSECTION (3)(a) OF THIS
4 SECTION, THE EXECUTIVE DIRECTOR SHALL ENSURE THAT THE INVITEES:".

5 Page 10 of the bill, line 15, strike "APPOINTEES" and substitute
6 "INVITEES".

7 Page 10 of the bill, strike lines 24 through 26.

8 Reletter succeeding paragraph accordingly.

9 Page 11 of the bill, strike lines 1 and 2 and substitute "EXECUTIVE
10 DIRECTOR MAY INVITE A NEW REPRESENTATIVE TO FILL THE VACANCY.".

11 Page 11 of the bill, strike lines 12 through 14.

12 Reletter succeeding paragraphs accordingly.

13 Amend the Health and Human Services Committee Report, dated
14 February 7, 2024, page 2, line 17, strike ""FOUR"." and substitute
15 ""TWO"".

16 Page 11 of the bill, strike lines 16 and 17 and substitute "BEFORE
17 OCTOBER 1, 2025, AND THE EXECUTIVE DIRECTOR OF THE STATE
18 DEPARTMENT, OR THE EXECUTIVE DIRECTOR'S DESIGNEE SERVING ON THE
19 ANALYSIS COLLABORATIVE, MAY CONVENE ADDITIONAL MEETINGS OF THE
20 ANALYSIS COLLABORATIVE AS DETERMINED BY CONSULTING WITH THE
21 MEMBERS OF THE ANALYSIS COLLABORATIVE AND THE SCHOOL OF PUBLIC
22 HEALTH.".

23 Page 11 of the bill, after line 22 insert:

24 "(d) ALL MEETINGS OF THE ANALYSIS COLLABORATIVE SHALL BE
25 HELD VIRTUALLY AND ALLOW FOR ATTENDANCE AND PARTICIPATION BY
26 MEMBERS OF THE ANALYSIS COLLABORATIVE AND MEMBERS OF THE
27 PUBLIC VIRTUALLY.

28 (e) THE ANALYSIS COLLABORATIVE MAY HOLD MEETINGS WITHOUT
29 A QUORUM OF THE MEMBERS PRESENT.".

30 Page 12 of the bill, line 1, strike "APPOINTED" and substitute "INVITED".

1 Page 12 of the bill, after line 9 insert:

2 "SECTION 3. In Colorado Revised Statutes, 23-18-308, **add**
3 (1)(m) as follows:

4 **23-18-308. Fee-for-service contracts - grants to local district**
5 **colleges - limited purpose - repeal.** (1) Subject to available
6 appropriations, the department shall enter into fee-for-service contracts
7 for the following purposes:

8 (m) THE COLORADO SCHOOL OF PUBLIC HEALTH'S ANALYSIS OF
9 MODEL LEGISLATION RELATED TO A STATEWIDE UNIVERSAL HEALTH-CARE
10 SYSTEM CONDUCTED PURSUANT TO SECTION 23-20-146.

11 **SECTION 4. Appropriation.** (1) For the 2024-25 state fiscal
12 year, \$240,735 is appropriated to the department of higher education. This
13 appropriation is from the general fund. To implement this act, the
14 department may use this appropriation for the college opportunity fund
15 program to be used for limited purpose fee-for-service contracts with
16 state institutions.

17 (2) For the 2024-25 state fiscal year, \$240,735 is appropriated to
18 the department of higher education. This appropriation is from
19 reappropriated funds received from the limited purpose fee-for-service
20 contracts with state institutions under subsection (1) of this section. To
21 implement this act, the department may use this appropriation for the
22 regents of the university of Colorado for allocation to the school of public
23 health.

24 (3) For the 2024-25 state fiscal year, \$448 is appropriated to the
25 legislative department. This appropriation is from the general fund. To
26 implement this act, the department may use this appropriation for the
27 general assembly.".

28 Renumber succeeding section accordingly.

29 Strike "ADVISORY TASK FORCE" and substitute "ANALYSIS
30 COLLABORATIVE" on: **Page 8**, line 23; **Page 9**, line 3; **Page 10**, line 27;
31 **Page 11**, lines 8, 11, 15, 18, 19, 23, and 27; and **Page 12 of the bill**, lines
32 1, 4, 6, and 7.

33 Page 1 of the bill, line 103, strike "ADVISORY TASK FORCE" and
34 substitute "ANALYSIS COLLABORATIVE".

35 Page 1 of the bill, line 107, strike "SYSTEM." and substitute "SYSTEM AND
36 MAKING AN APPROPRIATION.".
