A BILL FOR AN ACT
101 **CONCERNING THE DISTRIBUTION OF STOP THE BLEED MATERIALS TO**
102 **SCHOOLS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill requires the Colorado department of public health and environment (department) to distribute stop the bleed training materials and bleed control kits to K-12 schools that opt into receiving them. The bill also requires the department, in collaboration with the American college of surgeons' committee on trauma, to report the number of schools that opt in, the number of people who have been trained in stop the bleed

procedures in schools, the total number of stop the bleed control kits sent to schools, and the total cost of the program for each school year.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** part 14 to article
3 3.5 of title 25 as follows:

PART 14

STOP THE BLEED SCHOOL CONTROL KITS

25-3.5-1401. Stop the bleed school kits - report - definitions

7 - **repeal.** (1) THE DEPARTMENT SHALL DISTRIBUTE STOP THE BLEED [REDACTED]
8 CONTROL KITS TO EACH SCHOOL THAT CHOOSES TO ADMINISTER STOP THE
9 BLEED TRAINING.

10 (2) FOR THE 2023-24, 2024-25, AND 2025-26 STATE FISCAL YEARS,
11 THE GENERAL ASSEMBLY SHALL APPROPRIATE ONE HUNDRED FIFTY
12 THOUSAND DOLLARS TO THE DEPARTMENT FOR THE PURPOSE OF
13 PURCHASING AND DISTRIBUTING STOP THE BLEED CONTROL KITS TO HIGH
14 SCHOOLS, MIDDLE SCHOOLS, AND ELEMENTARY SCHOOLS. ANY
15 UNEXPENDED MONEY REMAINING AT THE END OF THE 2023-24 AND
16 2024-25 STATE FISCAL YEARS FROM THIS APPROPRIATION:

17 (a) DOES NOT REVERT TO THE GENERAL FUND OR ANY OTHER
18 FUND:

19 (b) MAY BE USED BY THE DEPARTMENT IN THE 2024-25 AND
20 2025-26 STATE FISCAL YEARS WITHOUT FURTHER APPROPRIATION: AND

21 (c) MUST NOT BE USED FOR ANY OTHER PURPOSE OTHER THAN THE
22 PURPOSE SET FORTH IN THIS SECTION

23 (d) THE DEPARTMENT SHALL PROVIDE EACH SCHOOL WITH ITS
24 ALLOTMENT OF BLEED CONTROL KITS AFTER A SCHOOL HAS HELD A STOP
25 THE BLEED TRAINING

3 (a) SCHOOLS WITH A POPULATION OF OVER ONE THOUSAND
4 STUDENTS THAT OPT IN RECEIVE TEN BLEED CONTROL KITS;

8 (c) SCHOOLS WITH A POPULATION OF LESS THAN FIVE HUNDRED
9 STUDENTS THAT OPT IN RECEIVE THREE BLEED CONTROL KITS.

10 (4) ON OR BEFORE JULY 1, 2024, AND ON OR BEFORE JULY 1 EACH
11 YEAR THEREAFTER THROUGH JULY 1, 2026, THE DEPARTMENT SHALL
12 COLLABORATE WITH THE AMERICAN COLLEGE OF SURGEONS' COMMITTEE
13 ON TRAUMA TO SUBMIT A REPORT TO THE HEALTH AND HUMAN SERVICES
14 COMMITTEE OF THE SENATE AND THE PUBLIC AND BEHAVIORAL HEALTH
15 AND HUMAN SERVICES COMMITTEE OF THE HOUSE OF REPRESENTATIVES,
16 OR ANY SUCCESSOR COMMITTEES, AND TO THE GOVERNOR ON THE
17 DISTRIBUTION OF STOP THE BLEED [REDACTED] CONTROL KITS. AT A MINIMUM, THE
18 REPORT MUST INCLUDE:

19 (a) THE TOTAL NUMBER OF SCHOOLS THAT OPTED IN TO RECEIVE
20 STOP THE BLEED  CONTROL KITS;

21 (b) THE TOTAL NUMBER OF PEOPLE IN SCHOOLS WHO HAVE BEEN
22 TRAINED IN STOP THE BLEED;

23 (c) THE TOTAL NUMBER OF STOP THE BLEED CONTROL KITS THAT
24 HAVE BEEN SENT TO SCHOOLS; AND

25 (d) THE TOTAL COST OF DISTRIBUTING THE STOP THE BLEED ■■■■■
26 CONTROL KITS.

27 (5) ANY CONTRACT OR AGREEMENT THAT THE DEPARTMENT

1 ENTERS INTO IN FURTHERANCE OF THIS SECTION IS EXEMPT FROM THE
2 REQUIREMENTS OF THE "PROCUREMENT CODE", ARTICLES 101 TO 112 OF
3 TITLE 24.

4 (6) AS USED IN THIS SECTION:

5 (a) "BLEED CONTROL" MEANS ACTIONS THAT CONTROL BLEEDING
6 FROM A PERSON WHO HAS SUFFERED A TRAUMATIC INJURY.

7 (b) "BLEED CONTROL KIT" MEANS A FIRST AID RESPONSE KIT
8 DEVELOPED BY STOP THE BLEED THAT CONTAINS:

9 (I) ONE Tourniquet ENDORSED BY THE UNITED STATES
10 DEPARTMENT OF DEFENSE COMMITTEE ON TACTICAL COMBAT CASUALTY
11 CARE;

12 (II) ONE COMPRESSION BANDAGE;

13 (III) ONE BLEEDING CONTROL BANDAGE;

14 (IV) PROTECTIVE GLOVES;

15 (V) ONE ~~MARKER~~; AND

16 (VI) ONE PAIR OF ~~SCISSORS~~.

17 

18 (c) "SCHOOL" MEANS A PUBLIC SCHOOL, SCHOOL DISTRICT, BOARD
19 OF COOPERATIVE SERVICES, CHARTER SCHOOL, OR INSTITUTE CHARTER
20 SCHOOL.

21 (d) "STOP THE BLEED" MEANS THE AMERICAN COLLEGE OF
22 SURGEONS' STOP THE BLEED PROGRAM THAT IS ADMINISTERED BY THE
23 AMERICAN COLLEGE OF SURGEONS' COMMITTEE ON TRAUMA.

24 (7) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2026.

25 **SECTION 2. Safety clause.** The general assembly hereby finds,
26 determines, and declares that this act is necessary for the immediate
27 preservation of the public peace, health, or safety.
