## **Bill Summary**

The bill requires the center of excellence (center) within the

HOUSE Amended 2nd Reading March 10, 2017 division of fire prevention and control within the department of public safety (department) to conduct a study concerning the integration of unmanned aircraft systems (UAS) within state and local government operations that relate to public safety. At a minimum, the study must:

- ! Identify the most feasible and readily available ways to integrate UAS technology within local and state government functions relating to public safety; and
- ! Include consideration of privacy concerns, costs, and timeliness of deployment.

The bill also creates an UAS pilot program (pilot program) to integrate UAS within state and local government operations that relate to public safety. The bill requires the center to operate the pilot program. The division of employment and training within the department of labor and employment may provide resources for training and development of eligible candidates of the pilot program.

On or before September 1, 2018, the center shall submit a report to the wildfire matters review committee and to the judiciary committees of the house of representatives and senate, or to any successor committees. The report must address each item of the center's study, as well as the results of the pilot program.

**SECTION 1. Legislative declaration.** (1) The general assembly hereby finds that:

- (a) In response to recent devastating fires and floods and the significant expenditures associated with them, the general assembly has made substantial investments in firefighting and other emergency-response technology;
- (b) Although emergency-response operations are steadily improving, newer technologies, including unmanned aircraft systems (UAS), are becoming available to further decrease response times and save lives and property from future catastrophic disasters;
- (c) Last year, the United States Congress enacted the "Federal Aviation Administration Extension, Safety, and Security Act of 2016", H.R. 636, section 2204 of which requires the administrator of the federal

aviation administration to enter into agreements with other federal agencies to "continue the expeditious authorization of safe unmanned aircraft system operations in support of firefighting operations"; and

- (d) A memorandum from President Barack Obama, dated February 15, 2015, and entitled "Promoting Economic Competitiveness While Safeguarding Privacy, Civil Rights, and Civil Liberties in Domestic Use of Unmanned Aircraft Systems", stated that "UAS technology continues to improve rapidly, and increasingly UAS are able to perform a variety of missions with greater operational flexibility and at a lower cost than comparable manned aircraft. A wide spectrum of domestic users...are using or expect to use these systems, which may play a transformative role in fields as diverse as urban infrastructure management, farming, public safety, coastal security, military training, search and rescue, and disaster response".
  - (2) The general assembly further finds that:
  - (a) The use of UAS by public safety organizations will create opportunities and jobs;
  - (b) The state should support the integration of UAS as a matter of economic development to develop the workforce, especially in rural areas where disasters sometimes occur;
  - (c) Persons who will find work as UAS operators need specialized, portable skills that involve public safety objectives as well as technical, operational concerns; and
  - (d) The promotion of UAS by the general assembly is consistent with the objectives of the "Colorado Career Advancement Act", part 2 of article 83 of title 8, Colorado Revised Statutes, and the work force development program set forth therein.

1	(3) Now, therefore, the general assembly declares that this act is
2	intended to help make Colorado the nation's center of expertise for the
3	integration of UAS into firefighting and other emergency operations,
4	building on the progress already made by the center of excellence for
5	advanced technology aerial firefighting within the department of public
6	safety.
7	SECTION 2. In Colorado Revised Statutes, 24-33.5-1228,
8	<b>amend</b> (3); and <b>add</b> (2.5)(c) and (2)(d) as follows:

2	(II) NOT LATER THAN ONE MONTH AFTER COMPLETING THE STUDY
3	DESCRIBED IN SUBSECTION (2.5)(c)(I) OF THIS SECTION, THE CENTER OF
4	EXCELLENCE SHALL SUBMIT A REPORT DESCRIBING THE RESULTS OF ITS

16	DATE OF THIS SECTION, THE CENTER OF EXCELLENCE SHALL OPERATE AN
17	UNMANNED AIRCRAFT SYSTEM PILOT PROGRAM, REFERRED TO WITHIN THIS
18	SECTION AS THE "PILOT PROGRAM", TO INTEGRATE UNMANNED AIRCRAFT

1	RECONSTRUCTION, AND EMERGENCY MANAGEMENT. UNMANNED
2	AIRCRAFT SYSTEM OPERATORS MAY BE COMPENSATED BY THE CENTER
3	DURING THEIR TRAINING.
4	(III) IN OPERATING THE PILOT PROGRAM, THE CENTER OF
5	EXCELLENCE SHALL NOT INTERFERE WITH ANY ACTIVE WILDFIRE
6	SUPPRESSION EFFORT UNLESS THE CENTER IS GRANTED PERMISSION TO
7	ASSIST IN SUCH EFFORT BY A SUPERVISING AGENCY WITH THE AUTHORITY
8	TO GRANT SUCH PERMISSION.

10	(3) (a) The division shall administer the Colorado firefighting air
11	corps fund, which fund is hereby created in the state treasury. The
12	division is authorized to MAY seek and accept gifts, grants,
13	reimbursements, investments, bond revenues, sales proceeds,
14	commissions for services, sponsorships, advertising fees, licensing fees,
15	profits, or donations from private or public sources for the purposes of
16	this section. The fund consists of all moneys MONEY that may be
17	appropriated to the fund by the general assembly, and all private and
18	public funds received through gifts, grants, reimbursements, investments,
19	bond revenues, sales proceeds, commissions for services, sponsorships,
20	advertising fees, licensing fees, profits, or donations that are transmitted
21	to the state treasurer and credited to the fund. All interest earned from the
22	investment of moneys MONEY in the fund are IS credited to the fund. The
23	moneys MONEY in the fund are hereby IS continuously appropriated for
24	the purposes indicated in paragraph (c) of this subsection (3) SUBSECTION
25	(3)(c) OF THIS SECTION. Any moneys MONEY not expended at the end of
26	the fiscal year remain REMAINS in the fund.
27	(b) The general assembly finds that the implementation of this

1	section does not rely entirely or in any part on the receipt of adequate
2	funding through gifts, grants, or donations. Therefore, the division is no
3	subject to the notice requirements specified in section 24-75-1303 (3).
4	(c) The division shall use the moneys MONEY in the Colorado
5	firefighting air corps fund for the PURPOSES OF SUBSECTION (2.5) OF THIS
6	SECTION AND FOR PAYING THE direct and indirect costs of maintaining the
7	Colorado firefighting air corps, including expenses associated with
8	acquisition, retrofitting, labor, equipment, supply, transportation, air
9	mobilization, repair, maintenance, and demobilization.
10	SECTION 3. Safety clause. The general assembly hereby finds
11	determines, and declares that this act is necessary for the immediate
12	preservation of the public peace, health, and safety.
