2 **SECTION 1.** In Colorado Revised Statutes, 12-245-217, **amend**
3 (2)(g) and (2)(h); and **repeal** (2)(i) as follows:

4 **12-245-217. Scope of article - exemptions.** (2) This article 245
5 does not apply to:

6 (g) Students who are enrolled in a school program and are
7 practicing as part of a school practicum or clinical program; OR

8 (h) A professional practicing auricular acudetox in accordance
9 with section 12-245-233. ~~or~~

10 ~~(i) Screeners conducting screenings pursuant to the sixth through~~
11 ~~twelfth grade mental health screening program created in section~~
12 ~~27-50-903.~~

13 **SECTION 2.** In Colorado Revised Statutes, **repeal** part 9 of
14 article 50 of title 27.

15 **SECTION 3. Appropriation - adjustments to 2025 long bill.**

16 (1) To implement this act, general fund appropriations made in the
17 annual general appropriation act for the 2025-26 state fiscal year to the
18 department of human services are adjusted as follows:

19 (a) The appropriation for health, life, and dental is decreased by
20 \$37,260;

21 (b) The appropriation for short-term disability is decreased by
22 \$146;

23 (c) The appropriation for paid family medical leave insurance is
24 decreased by \$936;

25 (d) The appropriation for unfunded liability amortization
26 equalization disbursement payments is decreased by \$20,798;

27 (e) The appropriation for use by the behavioral health

1 administration for program administration is decreased by \$260,978, and
2 the related FTE is decreased by 3.0 FTE; and

3 (f) The appropriation for use by the behavioral health
4 administration for the school mental health screening program is
5 decreased by \$2,536,706.

6 **SECTION 4. Safety clause.** The general assembly finds,
7 determines, and declares that this act is necessary for the immediate
8 preservation of the public peace, health, or safety or for appropriations for
9 the support and maintenance of the departments of the state and state
10 institutions.
