A BILL FOR AN ACT

CONCERNING A PROGRAM TO FUND THE ACQUISITION OF FIREARM DETECTION SOFTWARE FOR USE IN SCHOOLS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov.)

The bill establishes the school safety firearm detection funding program (program) in the office of school safety (office) to disburse money to local education providers to purchase, install, and operate firearm detection software for use in schools. The office administers the program.

In order to receive a disbursement, a local education provider must

submit an application. The office shall disburse program money to eligible applicants in the order the applications are received. A recipient shall use program money to purchase and operate firearm detection software to detect, and alert local education provider personnel and first responders about, the presence of visible, unholstered firearms on school property.

4	amend (3)(h) and (3)(i); and add (3)(j) as follows:

13	PERSONNEL AND FIRST RESPONDERS ABOUT, THE PRESENCE OF VISIBLE,
14	UNHOLSTERED FIREARMS ON SCHOOL PROPERTY. THE SOFTWARE MUST
15	MEET THE REQUIREMENTS SET FORTH IN SECTION 24-33.5-1812.
16	SECTION 2. In Colorado Revised Statutes, add 24-33.5-1812 as

18	DETERMINATION, THE OFFICE SHALL CONSIDER DEMONSTRATED
19	SUCCESSFUL INSTALLATION, MONITORING, AND REAL-WORLD DETECTIONS
20	BY THE SOFTWARE BY OTHER USERS.
21	(2) AN ELIGIBLE ENTITY THAT USES DISBURSEMENT PROGRAM
22	MONEY FOR FIREARM DETECTION SOFTWARE SHALL INCLUDE THE
23	FOLLOWING INFORMATION IN ITS REPORT TO THE DEPARTMENT REQUIRED
24	PURSUANT TO SECTION 24-33.5-1810 (6)(a):
25	(a) A DESCRIPTION OF ANY INCIDENTS INVOLVING DETECTION OF
26	A FIREARM BY THE FIREARM DETECTION SOFTWARE PURCHASED WITH
27	PROGRAM MONEY, THE RESPONSE TIME FROM LAW ENFORCEMENT FOR

1	EACH INCIDENT, AND ANY FALSE POSITIVE ALERTS MADE BY THE
2	SOFTWARE;
3	(b) THE LENGTH OF TIME THE FIREARM DETECTION SOFTWARE
4	PURCHASED WITH PROGRAM MONEY WAS INOPERABLE SINCE THE
5	SOFTWARE WAS ACTIVATED.
6	(3) In its annual presentation to the committees of
7	REFERENCE PURSUANT TO SECTION 24-33.5-1810 (6)(b), THE DEPARTMENT
8	SHALL INCLUDE A SUMMARY OF THE INFORMATION REPORTED TO IT BY
9	ELIGIBLE ENTITIES PURSUANT TO SUBSECTION (2) OF THIS SECTION.
10	SECTION 3. Safety clause. The general assembly finds,
11	determines, and declares that this act is necessary for the immediate
12	preservation of the public peace, health, or safety or for appropriations for
13	the support and maintenance of the departments of the state and state
14	institutions.
