After consideration on the merits, the Committee recommends the following:

SB22-100 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 2, line 3, strike "and (11)" and substitute "(11), (12), and (13)".
- 3 Page 2, strike line 11 and substitute:
  - 4 "REVIEW BOARD RECOMMENDATIONS PERTAINING, BUT NOT LIMITED TO:
    - 5 (a) IMPROVING COMMUNICATION AND INFORMATION-SHARING
    - 6 BETWEEN PUBLIC AND PRIVATE ORGANIZATIONS AND AGENCIES AS TO
    - 7 DOMESTIC VIOLENCE INCIDENTS AND RISK;
    - 8 (b) REDUCING THE INCIDENCE OF DOMESTIC VIOLENCE AND
    - 9 DOMESTIC VIOLENCE FATALITIES IN THE STATE; AND
    - 10 (c) IMPROVING RESPONSES TO DOMESTIC VIOLENCE INCIDENTS.".
- 11 Page 3, line 2, after "AND" insert "COULD BE PROVIDED".jj
- 12 Page 3, after line 4 insert:
  - 13 (12) (a) THE REVIEW BOARD SHALL COORDINATE WITH
  - 14 STAKEHOLDERS TO DEVELOP BEST PRACTICES FOR COLLECTING DATA ON
  - 15 DOMESTIC VIOLENCE-RELATED FATALITIES.
  - 16 (b) THE REVIEW BOARD AND LOCAL REVIEW TEAMS SHALL
  - 17 COORDINATE TO IMPLEMENT EFFECTIVE INFORMATION-SHARING RELATED
  - 18 TO IDENTIFIED DOMESTIC VIOLENCE FATALITIES.
- 19 (13)(a) THE REVIEW BOARD SHALL PERFORM OUTREACH TO LOCAL
- 20 GOVERNMENTS AND ORGANIZATIONS TO PROMOTE THE DEVELOPMENT OF
- 21 LOCAL REVIEW TEAMS.
- 22 (b) THE REVIEW BOARD SHALL PRIORITIZE DEVELOPMENT AND
- 23 SUPPORT OF LOCAL REVIEW TEAMS IN UNDERSERVED AND RURAL
- 24 COMMUNITIES.".

1 Page 4, strike lines 14 through 21 and substitute:

2           **"SECTION 4.** In Colorado Revised Statutes, 2-3-1203, **add**  
3 (18)(a)(II) as follows:

4           **2-3-1203. Sunset review of advisory committees - legislative**  
5 **declaration - definition - repeal.** (18) (a) The following statutory  
6 authorizations for the designated advisory committees will repeal on July  
7 1, 2027:

8           (II) THE DOMESTIC VIOLENCE FATALITY REVIEW BOARD CREATED  
9 IN SECTION 24-31-702.".
