### A BILL FOR AN ACT

101 CONCERNING THE NONDISCLOSURE OF SENSITIVE SPECIES 102 INFORMATION UNDER THE "COLORADO OPEN RECORDS ACT".

## **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Under the "Colorado Open Records Act", state agencies are required to provide public records when requested. The bill changes the definition of "public records" to exclude the portion of the record containing information that reveals the location or could be used to determine the location of an individual animal, a group of animals, a sensitive plant species, or a sensitive species habitat.

1	Be it enacted by the General Assembly of the State of Colorado:
2	<b>SECTION 1. Legislative declaration.</b> (1) The general assembly
3	hereby finds and declares that Colorado's wildlife and natural areas are
4	cherished by the people of this state and draw visitors from across the
5	world. Careful management of wildlife, sensitive plant species, and
6	natural habitat is critical to their long-term success and viability.
7	Information about the specific locations of these resources should be
8	safeguarded because:
9	(a) Publication of wildlife location data can result in detrimental
10	public pressure, harassment of wildlife, and destruction of sensitive
11	natural habitat;
12	(b) Increased public pressure and harassment negatively impacts
13	the survival and reproductive success of all wildlife, including game and
14	nongame species;
15	(c) Location data may be used improperly to locate game animals,
16	undermining principles of fair chase; and
17	(d) Sensitive plant species location data may be used by collectors
18	to unlawfully obtain specimens of the species.
19	SECTION 2. In Colorado Revised Statutes, 24-72-202, amend
20	(6)(b)(XIV) and $(6)(b)(XV)$ ; and <b>add</b> $(6)(b)(XVI)$ as follows:
21	24-72-202. Definitions. As used in this part 2, unless the context

23	(6) (b) "Public records" does not include:
24	(XIV) Pursuant to the "Colorado Partnership for Quality Jobs and
25	Services Act", part 11 of article 50 of this title 24, records created in
26	compliance with the requirements of a state employee partnership

1	agreement as specified in section 24-50-1111 (3)(d) and documents
2	created in connection with the dispute resolution process for an employee
3	partnership agreement as specified in section 24-50-1113 (2)(e); or
4	(XV) Granular coverage data, as defined in and submitted to the
5	office of information technology pursuant to section 24-37.5-119 (9)(m);
6	OR
7	(XVI) THE PORTION OF A RECORD THAT CONTAINS DATA OR
8	INFORMATION THAT REVEALS THE LOCATION OR COULD BE USED TO
9	DETERMINE THE LOCATION OF AN INDIVIDUAL ANIMAL, A GROUP OF
10	ANIMALS, A SENSITIVE PLANT SPECIES, OR A SENSITIVE SPECIES HABITAT.
11	SECTION 3. Act subject to petition - effective date -
12	applicability. (1) This act takes effect at 12:01 a.m. on the day following
13	the expiration of the ninety-day period after final adjournment of the
14	general assembly; except that, if a referendum petition is filed pursuant
15	to section 1 (3) of article V of the state constitution against this act or an
16	item, section, or part of this act within such period, then the act, item,
17	section, or part will not take effect unless approved by the people at the
18	general election to be held in November 2022 and, in such case, will take
19	effect on the date of the official declaration of the vote thereon by the
20	governor.
21	(2) This act applies to records requested on or after the applicable
