SENATE JOINT RESOLUTION 17-014

101 **CONCERNING THE DESIGNATION OF MARCH 2, 2017, AS "COLORADO**
102 **ARC DAY".**

1 WHEREAS, The days of forcing people with intellectual and
2 developmental disabilities into institutions are largely over; and

3 WHEREAS, More than 80,000 Coloradans with intellectual and
4 developmental disabilities now live, attend school, and work in our
5 communities; and

6 WHEREAS, For more than 60 years, the Arc has advocated for
7 community supports and services for people with intellectual and
8 developmental disabilities; and

9 WHEREAS, With 13 local chapters across the state, the Arc of

1 Colorado works every day to help children and adults with intellectual
2 and developmental disabilities, their families, and other advocates to
3 improve the service delivery system; and

4 WHEREAS, The Arc believes people with intellectual and
5 developmental disabilities are defined by their strengths, abilities, and
6 inherent value and not by their disabilities; and

7 WHEREAS, The Arc believes people with intellectual and
8 developmental disabilities belong in the community and have
9 fundamental moral, civil, and constitutional rights to be fully included
10 and to actively participate in all aspects of society; and

11 WHEREAS, The Arc knows that people with intellectual and
12 developmental disabilities, with appropriate resources and supports, can
13 make decisions about their own lives and must be heard on issues
14 affecting their lives; and

15 WHEREAS, The Arc is committed to working with the Colorado
16 General Assembly, state agencies, and all partners providing advocacy,
17 services, and support for people with intellectual and developmental
18 disabilities to increase resources and improve systems so that people can
19 live productive, healthy lives in the community; now, therefore,

20 *Be It Resolved by the Senate of the Seventy-first General Assembly*
21 *of the State of Colorado, the House of Representatives concurring herein:*

23 That we, the members of the Colorado General Assembly:

24 (1) Express our most sincere and deepest appreciation to the men
25 and women at Colorado chapters of the Arc for their commitment to
26 supporting and improving the quality of life for Coloradans with
27 intellectual and developmental disabilities; and

28 (2) Hereby declare March 2, 2017, to be "Colorado Arc Day".
