A BILL FOR AN ACT

101 CONCERNING AUTHORIZING THE COLORADO MOUNTED RANGERS AS
102 CERTIFIED RESERVE PEACE OFFICERS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The Colorado mounted rangers (rangers) are an all-volunteer, self-funded auxiliary, full-time, nonprofit law enforcement governmental unit organized to provide support and assistance to municipal governments and local, county, and state law enforcement agencies in the state. The rangers are created within the division of homeland security and emergency management (division) in the department of public safety.

The division shall employ a person to act as the interface between the division and the rangers, to exercise control over the peace officers, to maintain standards and training, and to evaluate the rangers' suitability for duty. The salary and benefits costs for the employee shall be paid by gifts, grants, and donations to the division. The rangers are supervised by a board of directors. The board of directors is comprised of 3 elected individuals and shall provide oversight and management of the rangers subject to the division.

The bill creates reserve peace officer category II status and confers that status to the Colorado mounted rangers.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. In Colorado Revised Statutes, **amend** 16-2.5-102 as follows:

16-2.5-102. Certified peace officer - P.O.S.T. certification **required.** The following peace officers shall meet all the standards imposed by law on a peace officer and shall be certified by the peace officers standards and training board, referred to in this article as the "P.O.S.T. board": A chief of police; a police officer; a sheriff; an undersheriff; a deputy sheriff; a Colorado state patrol officer; a town marshal; a deputy town marshal; a reserve police officer; a reserve deputy sheriff; a reserve deputy town marshal; the director of the Colorado bureau of investigation; a police officer or reserve police officer employed by a state institution of higher education; a Colorado wildlife officer; a Colorado parks and recreation officer; a Colorado police administrator or police officer employed by the Colorado mental health institute at Pueblo; an attorney general criminal investigator; a community parole officer; a public transit officer; a municipal court marshal; and the department of corrections inspector general; AND A COLORADO MOUNTED RANGER RESERVE PEACE OFFICER CATEGORY II.

SECTION 2. In Colorado Revised Statutes, add 16-2.5-152 as

15	SECTION 3. In Colorado Revised Statutes, 24-31-301, amend
16	(1), (2), (6), and (7) as follows:
17	24-31-301. Definitions. As used in this part 3, unless the context
18	otherwise requires:
19	(1) "Applicant" means any person seeking certification to serve
20	as a peace officer, or a reserve peace officer, OR A RESERVE PEACE
21	OFFICER CATEGORY II.
22	(2) "Certification" means the issuance to an applicant of a signed
23	instrument evidencing that such applicant has met the requirements
24	imposed by this part 3 and the P.O.S.T. board. Certification includes
25	"basic certification" and "provisional certification" that shall MUST be
26	issued to peace officers, "reserve certification" that shall MUST be issued
27	to reserve peace officers, "RESERVE PEACE OFFICER CATEGORY II

1	CERTIFICATION" THAT MUST BE ISSUED TO VOLUNTEER RESERVE PEACE
2	OFFICERS, and such additional certifications as the board may approve for
3	peace officers.
4	(6) "Training academy" means any school approved by the
5	P.O.S.T. board where peace officers, and reserve peace officers, AND
6	RESERVE PEACE OFFICERS CATEGORY II receive instruction and training.
7	(7) "Training program" means a course of instruction approved by
8	the P.O.S.T. board for peace officer or reserve peace officer certification,
9	RESERVE PEACE OFFICER CATEGORY II CERTIFICATION, and other peace
10	officer training programs.
11	SECTION 4. In Colorado Revised Statutes, 24-31-303, amend
12	(1) (g), (5) introductory portion, and (5) (b) as follows:
13	24-31-303. Duties - powers of the P.O.S.T. board. (1) The
14	P.O.S.T. board has the following duties:
15	(g) To promulgate rules and regulations deemed necessary by such
16	board for the certification of applicants to serve as peace officers, or
17	reserve peace officers, OR RESERVE PEACE OFFICERS CATEGORY II in the
18	state pursuant to the provisions of article 4 of this title;
19	(5) It is unlawful for any person to serve as a peace officer, as
20	described in section 16-2.5-102, C.R.S., or a reserve peace officer as
21	defined in section 16-2.5-110, C.R.S., OR A RESERVE PEACE OFFICER
22	CATEGORY II in this state unless such person:
23	(b) Has undergone both a physical and a psychological evaluation
24	to determine such person's fitness to serve as a peace officer, or a reserve
25	peace officer, OR A RESERVE PEACE OFFICER CATEGORY II. Such
26	evaluations shall have been performed within one year prior to the date
27	of appointment by a physician and either a psychologist or psychiatrist

2	SECTION 5. In Colorado Revised Statutes, 24-31-304, amend
3	(1) as follows:
4	24-31-304. Applicant for training - fingerprint-based criminal
5	history record check. (1) For purposes of this section, "training
6	academy" means a basic, or reserve peace officer, OR RESERVE PEACE
7	OFFICER CATEGORY II training program approved by the P.O.S.T. board
8	that is offered by a training academy, community college, college, or
9	university.
10	SECTION 6. In Colorado Revised Statutes, 24-31-305, amend
11	(1.7) (a) and (1.7) (b); and add (1.4) as follows:
12	24-31-305. Certification - issuance - renewal - revocation.
13	(1.4) RESERVE PEACE OFFICER CERTIFICATION CATEGORY II
14	REQUIREMENTS SHALL INCLUDE:
15	(a) SUCCESSFUL COMPLETION OF A HIGH SCHOOL EDUCATION OR
16	ITS EQUIVALENT;
17	(b) SUCCESSFUL COMPLETION OF ONE HUNDRED TWENTY HOURS
18	RESERVE TRAINING APPROVED BY THE P.O.S.T. BOARD; AND
19	(c) CURRENT FIRST AID AND CARDIOPULMONARY RESUSCITATION
20	CERTIFICATES OR THEIR EQUIVALENTS.
21	(1.7) (a) Unless revoked, a basic certification, or reserve
22	certification, OR RESERVE PEACE OFFICER CATEGORY II CERTIFICATION

25	(b) If a basic or reserve certificate OR RESERVE PEACE OFFICER
26	CATEGORY II CERTIFICATE holder has not served as a peace officer or

2	the end of such three-year period, unless the certificate holder is then
3	serving as a peace officer, or reserve peace officer, OR RESERVE PEACE

5	SECTION 7. In Colorado Revised Statutes, 24-31-307, amend
6	(1) as follows:
7	24-31-307. Enforcement. (1) The P.O.S.T. board shall have the
8	power to direct the attorney general to enforce the provisions of this part
9	3 through an action in district court for injunctive or other appropriate
10	relief against:
11	(a) Any individual undertaking or attempting to undertake any
12	duties as a peace officer, or a reserve peace officer, OR A RESERVE PEACE
13	OFFICER CATEGORY II in this state in violation of this part 3; and
14	(b) Any agency permitting any individual to undertake or attempt
15	to undertake any duties as a peace officer, or a reserve peace officer, OR
16	A RESERVE PEACE OFFICER CATEGORY II in this state under the auspices of
17	such agency in violation of this part 3.
18	SECTION 8. In Colorado Revised Statutes, add 24-33.5-1616 as
19	follows:
20	24-33.5-1616. Colorado mounted rangers. (1) (a) THERE IS
21	HEREBY CREATED AND ESTABLISHED WITHIN THE DIVISION THE COLORADO
22	MOUNTED RANGERS, REFERRED TO HEREIN AS "RANGERS". THE RANGERS
23	ARE AN ALL-VOLUNTEER, SELF-FUNDED AUXILIARY, FULL-TIME,
24	NONPROFIT LAW ENFORCEMENT GOVERNMENTAL UNIT ORGANIZED TO
25	PROVIDE SUPPORT AND ASSISTANCE TO MUNICIPAL GOVERNMENTS AND
26	LOCAL, COUNTY, AND STATE LAW ENFORCEMENT AGENCIES IN THE STATE.
27	(b) THE DIVISION SHALL EMPLOY A DEDSON TO ACT AS THE

1	INTERFACE BETWEEN THE DIVISION AND THE KANGERS TO EXERCISE
2	CONTROL OVER THE RESERVE PEACE OFFICERS CATEGORY II IN
3	CONJUNCTION WITH THE RANGER'S BOARD OF DIRECTORS, TO MAINTAIN
4	STANDARDS AND TRAINING, AND TO EVALUATE THE RANGERS' SUITABILITY
5	FOR DUTY. THE SALARY AND BENEFITS COSTS FOR THE EMPLOYEE SHALL
6	BE PAID BY THE GIFTS, GRANTS, OR DONATIONS TO THE DIVISION.
7	(c) THE RANGERS ARE AN INSTRUMENT OF A MUNICIPALITY FOR
8	INSURANCE PURPOSES.
9	(2) THE RANGERS ARE SUPERVISED BY A BOARD OF DIRECTORS.
10	THE BOARD OF DIRECTORS IS COMPRISED OF THREE ELECTED OFFICIALS.
11	THE BOARD SHALL PROVIDE OVERSIGHT AND MANAGEMENT OF THE
12	RANGERS SUBJECT TO THE DIVISION.
13	(3) THE RANGERS ARE A RESERVE PEACE OFFICER CATEGORY II
14	AGENCY. THE RANGERS SHALL MAINTAIN THEIR OWN PEACE OFFICERS
15	STANDARDS AND TRAINING BOARD COMPLIANT POLICIES AND
16	PROCEDURES, INCLUDING A CHAIN OF COMMAND AND A REVIEW POLICY
17	FOR INDIVIDUAL RANGER CONDUCT.
18	(4) THE DIVISION SHALL ISSUE IDENTIFICATION CARDS FOR ALI
19	CERTIFIED RESERVE PEACE OFFICER CATEGORY II RANGERS.
20	SECTION 9. Safety clause. The general assembly hereby finds
21	determines, and declares that this act is necessary for the immediate
22	preservation of the public peace, health, and safety.
