Fiscal note status: This revised fiscal note reflects the reengrossed bill, as amended by the Senate Judiciary Committee.

Summary Information

Overview. The bill creates a working group to study colorimetric field drug tests.

Types of impacts. The bill is projected to affect the following areas in FY 2025-26 only:

- State Expenditures

Appropriations. The bill requires and includes an appropriation of \$1,008 to the Legislative Department.

Summary of Legislation

The bill requires the Director of Legislative Council Staff to use a request for proposals process to contract with a nonprofit organization that will voluntarily staff and facilitate a Colorimetric Field Drug Test Working Group. The working group will not be required to meet if a contract with a nonprofit is not established. The bill outlines the membership of the working group, and requires appointments to be made by July 1, 2025, and work to be accomplished over the course of three meetings between July and December.

Background

A colorimetric field drug test is a presumptive test that uses a chemical reagent which changes color depending on what substances are present in the sample.

State Expenditures

The bill increases General Fund expenditures by \$1,008 in FY 2025-26 only. It will also increase workload in the Legislative Department and in agencies involved in the working group.

General Assembly

Costs to the General Assembly will increase by \$1,008 for three members to attend three virtual meetings at a \$111.95 per diem rate. Travel reimbursement is not required as meetings will be virtual.

Legislative Council Staff

In FY 2025-26, Legislative Council Staff will issue a request for proposals. This work can be accomplished within existing appropriations.

Other Agency Impacts

Workload to the various agencies involved in the working group will increase to participate in the working group. The fiscal note assumes any expenses will be reimbursed by the individual agencies, and that this work and cost can be accomplished within existing resources.

Effective Date

The bill takes effect upon signature of the Governor, or upon becoming law without his signature.

State Appropriations

For FY 2025-26, the bill requires and includes an appropriation of \$1,008 to the Legislative Department.
