A BILL FOR AN ACT

CONCERNING THE NATUROPATHIC DOCTOR FORMULARY.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov.)

The bill clarifies that the naturopathic doctor formulary (formulary) may include prescription classes of medicines and adds certain medicines to the formulary, including all legend drugs and, for a naturopathic doctor with a federal drug enforcement administration registration, all drugs listed on schedules III through V under the "Uniform Controlled Substances Act of 2013".

1	Be it enacted by the General Assembly of the State of Colorado:
2	SECTION 1. In Colorado Revised Statutes, 12-250-103, amend
3	(12) as follows:
4	12-250-103. Definitions. As used in this article 250, unless the
5	context otherwise requires:
6	(12) "Naturopathic formulary" means the list of PRESCRIPTION
7	AND nonprescription classes of medicines determined by the director that
8	naturopathic doctors use in the practice of naturopathic medicine.
9	"Naturopathic formulary" ALSO includes any prescription substance or
10	device that is authorized under this article 250.
11	SECTION 2. In Colorado Revised Statutes, 12-250-104, amend
12	(2)(c)(II) as follows:
13	12-250-104. Naturopathic medicine advisory committee -
14	creation - membership - duties. (2) The advisory committee shall meet
15	at least once each year to:
16	(c) (II) Make recommendations to the director on whether there
17	should be additions TO THE NATUROPATHIC FORMULARY, other than ANY
18	SCHEDULE I OR II controlled substances to the naturopathic formulary.
19	Possible additions may include only biological substances including
20	vitamins, minerals, nutritive substances, extracts, and their products and
21	residues or devices identified in the federal "Controlled
22	SUBSTANCES ACT", 21 U.S.C. SEC. 801 ET SEQ., AS AMENDED.
23	SECTION 3. In Colorado Revised Statutes, 12-250-105, add
24	(1)(f) as follows:
25	12-250-105. Director powers and duties - rules. (1) In addition
26	to any other powers and duties granted or imposed on the director under
27	this article 250 or articles 20 and 30 of this title 12, the director shall:

4	SECTION 4. In Colorado Revised Statutes, 12-250-106, amend
5	(1)(c)(I) and $(2)(a)$ as follows:

7	naturopathic doctors - exclusions - protected activities - definition -
8	rules. (1) The practice of naturopathic medicine by a naturopathic doctor
9	includes the following:
10	(c) (I) Obtaining, dispensing, administering, INJECTING, ordering,
11	or prescribing, as specified, medicines listed in the naturopathic
12	formulary, which includes:
13	(A) Epinephrine to treat anaphylaxis ALL LEGEND DRUGS;
14	(A.5) WITH A VALID REGISTRATION FROM THE FEDERAL DRUG
15	ENFORCEMENT ADMINISTRATION, ALL DRUGS IN SCHEDULES III THROUGH
16	V as listed in sections 18-18-205 to 18-18-207;
17	(B) Barrier contraceptives, excluding intrauterine devices;
18	(C) Oxygen; but only for emergency use;
19	(D) Vitamins, B6 and B12 MINERALS, TRACE MINERALS, ENZYMES,
20	AND FOOD;
21	(E) Substances that are regulated by the federal food and drug
22	administration but that do not require a prescription order to be dispensed
23	ALL BIOLOGICAL SUBSTANCES, INCLUDING EXTRACTS AND THEIR
24	PRODUCTS AND RESIDUES;
25	(F) Vaccines, in accordance with the ACIP guidelines, for patients
26	who are at least eighteen years of age; and
27	(G) Any additions to the naturopathic formulary as determined by

3	TOPICAL PREPARATIONS;
4	(H) HOMEOPATHIC PREPARATIONS;
5	(I) ALL AMINO ACIDS AND AMINO ACID COMBINATIONS;
6	(J) ALL BOTANICAL EXTRACTS AND THEIR DERIVATIVES;
7	(K) ELECTROLYTES AND FLUID REPLACEMENT;
8	(L) HORMONES; AND
9	(M) ANY ADDITIONS TO THE NATUROPATHIC FORMULARY AS
10	DETERMINED BY THE DIRECTOR BY RULE.
11	(2) A naturopathic doctor shall not:
12	(a) Prescribe, dispense, administer, or inject a ANY SCHEDULE I OR
13	II controlled substance or device identified in the federal "Controlled
14	Substances Act", 21 U.S.C. sec. 801 et seq., as amended;
15	SECTION 5. Act subject to petition - effective date. This act
16	takes effect at 12:01 a.m. on the day following the expiration of the
17	ninety-day period after final adjournment of the general assembly; except
18	that, if a referendum petition is filed pursuant to section 1 (3) of article V
19	of the state constitution against this act or an item, section, or part of this
20	act within such period, then the act, item, section, or part will not take
21	effect unless approved by the people at the general election to be held in
22	November 2024 and, in such case, will take effect on the date of the
23	official declaration of the vote thereon by the governor.
