Joint Technology Committee. The bill extends the deadline for the office of information technology's first annual report on the statewide longitudinal data system from April 15, 2026, to September 15, 2026.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-37.5-125, **amend**
3 (7)(b)(I) introductory portion as follows:

4 **24-37.5-125. Colorado statewide longitudinal data system -**
5 **education and workforce - postsecondary workforce readiness**
6 **programs - appropriation - cash fund - report - definitions - repeal.**

7 (7) (b) (I) Notwithstanding section 24-1-136 (11)(a)(I), beginning ~~April~~
8 ~~15, 2026~~ SEPTEMBER 15, 2026, and each April 15 thereafter, the office
9 shall submit an annual report to the education committees of the house of
10 representatives and the senate, or their successor committees, the state
11 board of education, and the governor. Subject to data availability, the
12 annual report must summarize key findings from education and workforce
13 outcomes and education and workforce readiness, including, at a
14 minimum:

15 **SECTION 2. Act subject to petition - effective date.** This act
16 takes effect at 12:01 a.m. on the day following the expiration of the
17 ninety-day period after final adjournment of the general assembly; except
18 that, if a referendum petition is filed pursuant to section 1 (3) of article V
19 of the state constitution against this act or an item, section, or part of this
20 act within such period, then the act, item, section, or part will not take
21 effect unless approved by the people at the general election to be held in
22 November 2026 and, in such case, will take effect on the date of the
23 official declaration of the vote thereon by the governor.
