**A BILL FOR AN ACT**  
101      **CONCERNING THE SPONSORSHIP OF SUNSET BILLS.**

**Bill Summary**

Current law provides that, for bills introduced pursuant to the sunset review process:

- The speaker of the house of representatives shall assign the proposed bill to a representative for sponsorship in the house of representatives in odd-numbered years; and
- The president of the senate shall assign the proposed bill to a senator for sponsorship in the senate in even-numbered years.

The bill requires that before assigning bill sponsors, the speaker of the house of representatives and the president of the senate must consult with their respective minority leaders and receive permission from the sponsor to be named to the sunset bill.

1       *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 24-34-104, amend  
3       (6)(d)(III) as follows:

4           **24-34-104. General assembly review of regulatory agencies  
5       and functions for repeal, continuation, or reestablishment - legislative  
6       declaration - repeal.** (6) (d) (III) AFTER CONSULTING WITH THE  
7       MINORITY LEADER OF THE HOUSE OF REPRESENTATIVES AND THE SENATE,  
8       RESPECTIVELY, AND RECEIVING PERMISSION FROM THE REPRESENTATIVE  
9       OR SENATOR TO BE ADDED AS THE BILL SPONSOR:

10           (A) The speaker of the house of representatives shall assign the  
11       proposed bill to a representative for sponsorship in the house of  
12       representatives in odd-numbered years; AND

13           (B) The president of the senate shall assign the proposed bill to  
14       a senator for sponsorship in the senate in even-numbered years.

15           **SECTION 2. Act subject to petition - effective date.** This act  
16       takes effect at 12:01 a.m. on the day following the expiration of the  
17       ninety-day period after final adjournment of the general assembly; except  
18       that, if a referendum petition is filed pursuant to section 1 (3) of article V  
19       of the state constitution against this act or an item, section, or part of this  
20       act within such period, then the act, item, section, or part will not take  
21       effect unless approved by the people at the general election to be held in  
22       November 2022 and, in such case, will take effect on the date of the  
23       official declaration of the vote thereon by the governor.
