## **Current Appropriations Clause in Bill**

The bill requires but does not contain an appropriation clause.

## **Description of Amendments in This Packet**

- **J.001** Staff has prepared amendment **J.001** (attached) to add a provision appropriating a total of \$1,681,600 General Fund to the Department of Human Services for FY 2021-22.
- L.005 Bill Sponsor amendment L.005 (attached) makes a techical correction to add "educational organizations" to two locations in the bill. An amendment was added during the Senate State, Veterans, and Military Affairs Committee that added educational organizations to the bill. A separate amendment was adopted that referred to nonprofit organizations, but not educational organizations. This amendment adds references to educational organizations in these two spots.

#### **Points to Consider**

#### General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2021-22 based on the March 2021 Legislative Council Staff revenue forecast. The budget package includes a set aside of \$48.0 million General Fund for bills that require General Fund appropriations for FY 2021-22. This bill requires a General Fund appropriation of \$1,681,600 for FY 2021-22, reducing the \$48.0 million set aside by the same amount, and is projected to require General Fund appropriations of \$2,963,200 in FY 2022-23, reducing the amount of General Fund available for other purposes.
