After consideration on the merits, the Committee recommends the following:
HB25-1198 be amended as follows, and as so amended, be referred to the Committee on <u>Appropriations</u> with favorable recommendation:
Amend printed bill, page 4, line 16, strike "definition." and substitute "notice to revisor - definition.".
Page 4, line 22, strike "FIFTEEN" and substitute "TWENTY-ONE".
Page 5, after line 2 insert:
"(III) ONE MEMBER REPRESENTING THE DEPARTMENT OF AGRICULTURE, APPOINTED BY THE COMMISSIONER OF AGRICULTURE;  (IV) ONE MEMBER REPRESENTING COUNTIES AND COMMISSIONERS ACTING TOGETHER, OR ANY SUCCESSOR ORGANIZATION, APPOINTED BY THE EXECUTIVE DIRECTOR OF COUNTIES AND COMMISSIONERS ACTING TOGETHER OR THE EXECUTIVE DIRECTOR'S DESIGNEE;  (V) THREE MEMBERS REPRESENTING COMMUNITY PLANNING PROFESSIONALS, APPOINTED BY THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF LOCAL AFFAIRS;  (VI) ONE MEMBER WHO IS A COLORADO RESIDENT REPRESENTING AN INDIGENOUS COMMUNITY, AS DEFINED IN SECTION 24-33.5-2601 (2). AND WHO IS A MEMBER OF A FEDERALLY RECOGNIZED TRIBE WITH HISTORIC TIES TO COLORADO;".

Page 6, line 14, strike "(3)(a)(IX)" and substitute "(3)(a)(XIII)".

21 Page 6, line 20, strike "(3)(a)(VI)" and substitute "(3)(a)(X)".

Page 6, line 15, strike "(3)(a)(XII)" and substitute "(3)(a)(XVI)".

  SECTION UNTIL IT RECEIVES AN AMOUNT OF GIFTS, GRANTS, AND
  DONATIONS THAT IT DEEMS NECESSARY TO IMPLEMENT THIS SECTION.

THE DIRECTOR SHALL NOTIFY THE REVISOR OF STATUTES IN WRITING OF THE DATE ON WHICH THE CONDITION SPECIFIED IN THIS SUBSECTION (11) HAS O C C U R R E D B Y E M A I L I N G T H E N O T I C E T O
